Summary and Highlights

The Jharkhand Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **61** candidates, who are contesting in the following constituencies in the Jharkhand, Lok Sabha Phase 5 Elections.

1. Hazaribagh
2. Khunti
3. Ranchi
4. Kodarma

Criminal Background

- **Candidates with Criminal Cases:** Out of 61 candidates analyzed, **13(21%)** candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **9(15%)** candidates have declared serious criminal cases against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
