केरल इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने केरल विधानसभा चुनाव 2021 में मुख्यमंत्री सहित 21 में से 20 मंत्रियों के शपथपत्रों का विश्लेषण किया। **CPI(M)** के एक मंत्री **वी सिवनकुट्टी** का शपथपत्र स्पष्ट ना होने के कारण उनका विश्लेषण नहीं किया गया है।

यह जानकारी 2021 केरल विधानसभा चुनाव से पहले उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित हैं।

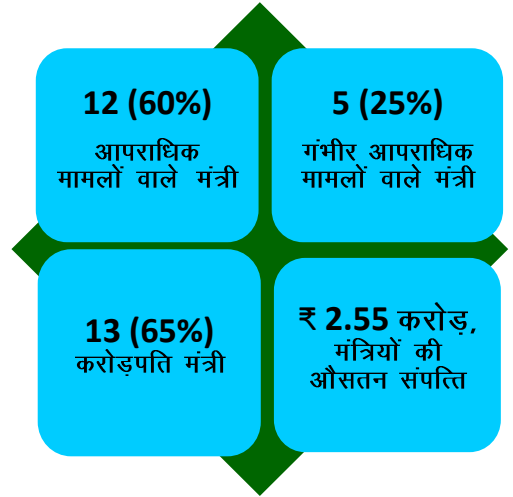

- ☞ **मंत्रियों की आयु:** 13 (65 प्रतिशत) मंत्रियों ने अपनी आयु 41 से 60 वर्ष के बीच घोषित की है, जबकि 7 (35 प्रतिशत) मंत्रियों ने अपनी आयु 61 से 80 वर्ष के बीच घोषित की हैं।
