3. I have considered your application referred to above, and your various contentions contained therein. The information / documents sought by you can not be provided in terms of provisions of section 8(j) read with section 8(e) of the RTI Act, 2005. The order of the DCIT, Central Circle-2, Patna is upheld subject to the discussion herein above.

With this your appeal under reference is dismissed.
