Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **all 25** candidates who are contesting in the **Lok Sabha Bye Elections** being held in the **Bhandara-Gondiya** and **Palghar (ST)** constituencies of **Maharashtra** on **28th May, 2018**.

Criminal Background

- **Candidates with Criminal Cases:** 6 (24%) out of 25 analyzed candidates have declared criminal cases against themselves.

- **Candidates with Serious Criminal Cases:** 4 (16%) out of 25 analyzed candidates have declared serious criminal cases against themselves like **undue influence or personation at an election, voluntarily causing hurt to deter public servant from his duty, theft, etc.**

- **Party wise Candidates with declared Criminal Cases:** 1 (100%) candidate each from **Bahujan Vikas Aaghadi, Akhil Bharatiya Manavata Paksha, Bahujan Republican Socialist Party** and **Nationalist Congress Party** have declared criminal cases against themselves in their affidavits.

- **Party wise Candidates with declared Serious Criminal Cases:** 1 (100%) candidate each from **Bahujan Vikas Aaghadi, Akhil Bharatiya Manavata Paksha** and **Nationalist Congress Party** have declared serious criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

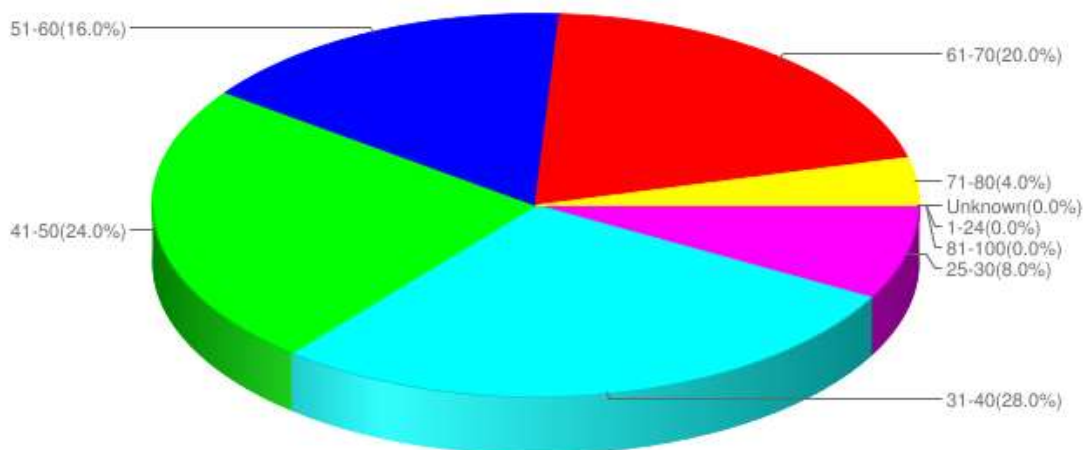

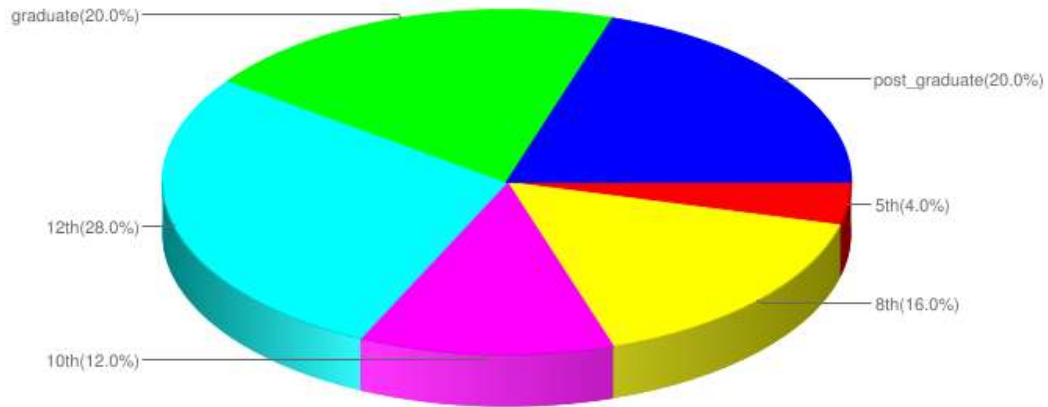
