एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और नेशनल इलेक्शन वॉच ने लोक सभा चुनाव 2024 और वर्तमान राज्य सभा से प्रधान मंत्री सहित 72 में से 71 मंत्रियों के शपथपत्रों का विश्लेषण किया है। जॉर्ज कुरियन के विवरण का विश्लेषण नहीं किया गया है, क्योंकि वर्तमान में वो किसी भी सदन के सदस्य नहीं हैं और उन्होंने लोक सभा चुनाव भी नहीं लड़ा है।
