करोड़पति हैं हमारे उम्मीदवार न वाहन है, न पेन नंबर

मध्यप्रदेश विधानसभा चुनाव में किस्मत आजमाने वाले अनेक करोड़पति उम्मीदवारों के पास न तो अपने वाहन हैं और न ही वे आयकर के पर्सनल अकाउंट्स नंबर (पेन) के बारे में कुछ जानते हैं। दूसरी तरफ, कुछ उम्मीदवारों की कुल संपत्ति 20 हजार रुपए से कम है और पांच उम्मीदवार ऐसे भी हैं जिनके पास संपत्ति के नाम पर एक धेला भी नहीं है।

चुनाव डेस्क, भोपाल. उम्मीदवारी के पर्चों के साथ दाखिल शपथपत्र के मुताबिक कांग्रेस, भाजपा, भारतीय जनशक्ति (भाजश), बहुजन समाज पार्टी (बसपा) और समाजवादी पार्टी (सपा) के 205 उम्मीदवार एक करोड़ रुपयों से अधिक की संपत्ति के मालिक हैं, लेकिन इनमें से 58 को अपने पेन नंबर के बारे में कुछ नहीं मालूम। कुल 266 प्रत्याशियों ने खुद को वाहन-विहीन घोषित किया है, लेकिन इनमें से 29 ऐसे भी हैं जिनकी संपत्ति 75 लाख से अधिक है। यह जानकारी वर्ष 2003 से चुनावों पर नजर रखने वाले दिल्ली के एनजीओ एसोसिएशन ऑफ डेमोक्रेटिक रिफॉर्मर्स (एडीआर) से जुड़े 'मध्यप्रदेश इलेक्शन वॉच' (एमपीईडब्ल्यू) ने प्रत्याशियों द्वारा दाखिल शपथपत्रों के विश्लेषण के आधार पर उजागर की है। रविवार को राज्य के चुनाव में उतरी पांच प्रमुख पार्टियों के 1084 उम्मीदवारों पर रिपोर्ट जारी करते हुए एमपीईडब्ल्यू के राकेश रंजन ने बताया कि चुनाव में उतरे बाकी के पांच राज्यों में भी इसी तरह की रिपोर्ट जारी की गई है।

उम्मीदवारों की अपराधिक पृष्ठभूमि

इस बार चुनाव के मैदान में उतरी सभी 55 राजनीतिक पार्टियों ने अपराधिक पृष्ठभूमि के प्रत्याशियों से कोई परहेज नहीं किया है। कांग्रेस ने जहां 24.53 प्रतिशत अपराधिक पृष्ठभूमि के उम्मीदवारों को उतारकर अक्कल दर्जा हासिल किया है, वहीं भाजपा 19.16 प्रतिशत अपराधिक पृष्ठभूमि के उम्मीदवारों के साथ ज्यादा पीछे नहीं है। उत्तरप्रदेश में अपने-अपने झंडे गाड़ने के बाद सपा (13.97 प्रतिशत) और बसपा (13.81 प्रतिशत) मध्यप्रदेश में भी अपराधियों को शह देने में पीछे नहीं है। साध्वी के नेतृत्व वाली अपेक्षाकृत नई भाजपा पार्टी ने भी 16.48 प्रतिशत अपराधिक पृष्ठभूमि वाले उम्मीदवारों को उतारकर इस क्षेत्र में भी कासर नहीं छोड़ी है।

कर्ज में दबे हैं भावी प्रतिनिधि

भाजपा के 25.58 प्रतिशत उम्मीदवार सरकार के दस लाख रुपयों से ज्यादा के देनदार हैं। इसी तरह कांग्रेस के 24.88 प्रतिशत, बसपा के 11.42 प्रतिशत, भाजश के 6.55 प्रतिशत और सपा के 5.55 प्रतिशत प्रत्याशी दस लाख रुपयों से अधिक के कर्जदार हैं। एक करोड़ से ज्यादा की देनदारी वाले कांग्रेस के छह, भाजपा के तीन और बसपा के एक उम्मीदवार हैं।

शिक्षित हैं अपराधी

विडंबना है कि अपराधिक पृष्ठभूमि वाले कर्जदार उम्मीदवारों में शिक्षा का प्रतिशत संतोषप्रद है। पढ़ताल में शामिल की गई पांच पार्टियों के 33.36 प्रतिशत उम्मीदवार ग्रेजुएट हैं और 16.03 प्रतिशत पोस्ट-ग्रेजुएट। क्या यह शिक्षा के नकारात्मक प्रभाव की ओर एक इशारा है?



1200 एनजीओ का गठबंधन

देशभर के करीब 12 सौ एनजीओ के गठबंधन एसोसिएशन ऑफ डेमोक्रेटिक रिफॉर्मर्स (एडीआर) की याचिका पर सुप्रीम कोर्ट ने मार्च 2003 में प्रत्याशियों की अपराधिक, आर्थिक और शैक्षणिक पृष्ठभूमि पर शपथपत्र दाखिल करने के आदेश दिए थे। तभी से एडीआर विभिन्न राज्यों के इलेक्शन वॉच के माध्यम से राज्य विधानसभाओं और संसद के चुनावों में खड़े होने वाले उम्मीदवारों पर रिपोर्ट जारी करता रहा है।

चुनावी दंगल में ताल ठोक रहे हैं करोड़पति

नई दिल्ली। दिल्ली विधानसभा के चुनावी दंगल में अकूत संपत्ति के कई मालिक विधायक बनने को कूदे हैं। सबसे अमीर होने का रिकार्ड महारौली से बसपा प्रत्याशी वेदप्रकाश के नाम दर्ज हुआ है। वेदप्रकाश ने बसपा के ही छतरपुर से उम्मीदवार कंवरसिंह तंवर को पछाड़ दिया है। वहीं पांच अकूत संपत्ति वाले प्रत्याशियों की सूची में भाजपा के दो उम्मीदवार भी शामिल हैं। जबकि कांग्रेस के सबसे अमीर प्रत्याशी तुगलकाबाद के शीशपाल सिंह हैं। वहीं दूसरी तरफ पांच उम्मीदवार ऐसे भी हैं जिनके पास न तो कोई नगदी है और न ही किसी तरह की स्थायी संपत्ति है।

चुनावी दंगल में हर आर्थिक वर्ग के उम्मीदवार उतरे हैं। प्रत्याशियों में 153 ऐसे हैं जिन्होंने एक करोड़ रुपये से

अधिक की संपत्ति दिखाई है। इनमें से 44

प्रत्याशियों ने पांच करोड़ से अधिक की संपत्ति शपथपत्र में दिखाई है। करोड़पति प्रत्याशियों में भाजपा के 47, कांग्रेस के 41 और बसपा के 32 प्रत्याशी शामिल हैं। वहीं दूसरी तरफ 12 उम्मीदवार ऐसे भी मैदान में उतरे हैं जिनके पास न तो नगदी है और न ही कोई बैंक बैलेंस है। इतना ही नहीं पांच प्रत्याशियों के पास तो कोई अचल संपत्ति भी नहीं है। ऐसे उम्मीदवार भी मैदान में 21 उतरे हैं जिनके पास कोई वाहन नहीं है। इसमें पांच भाजपा और चार कांग्रेस के उम्मीदवार हैं। एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म (एडीआर) और उनके सहयोगी की दिल्ली इलेक्शन वॉच रिपोर्ट बताती है कि अथाह संपत्ति होने के बावजूद 39 उम्मीदवारों ने अपना पैन नंबर भी शपथ पत्र में नहीं लिखा है जबकि ऐसा प्रावधान है।

Kaun Banega MLA? Crorepati!

New Delhi: The more money you have, greater the chances of winning a seat. That's the mantra emerging from the recent assembly polls in a study of candidates' affidavits filed with their nomination papers.

Crorepati candidates have won 40% seats in the elections from a total of 629 seats across the states of Rajasthan, Madhya Pradesh, Chhattisgarh, Mizoram and Delhi. Fewer than 3% candidates, with assets less than Rs 5 lakh, have triumphed, shows the report prepared by Association for Democratic Reforms as part of the New Election Watch campaign. ADR is a collective of more than 1,200 NGOs and citizens groups working for electoral reforms.

The average Delhi assembly MLA of 2008 is worth Rs 2.86 crore. There isn't much to choose financially between the average BJP (Rs 2.8 cr) and the Congress (Rs 2.7 cr) MLA. Interestingly, the average asset of the six BSP MLAs

you have, better the chances of winning," says Anil Bairwal, national coordinator, ADR. Activist Nikhil Dey elaborates: "The trend shows polls are almost a game of kaun banega crorepati. If you compare the figures with last time's elections, you will find assets have increased by an average of Rs 1 crore in five years of holding office."

in Rajasthan works out to Rs 3.45 crore.

In Delhi, 31% of crorepatris with assets above Rs 5 crore emerged successful whereas no candidate with less than Rs 5 lakh won. The contrast is sharper in Chhattisgarh where 50%, or every second contesting crorepati with assets more than Rs 3 crore, prevailed. In comparison, among candidates with kitties of less than Rs 5 lakh, only 2% were victorious.

There is a clear link between high finance and the chance of bagging a seat. "We found that the more money

इलेक्शन वाच का पांचवां सम्मेलन

नई दिल्ली (स.ड.)। नेशनल इलेक्शन वाच का चुनावी और राजनीतिक सुधारों पर पांचवां राष्ट्रीय सम्मेलन नवंबर में 31 जनवरी को मुंबई में आयोजित होने जा रहा है। राजनीतिक और चुनावी सुधारों के लिए प्रतिबद्ध करीब बारह सौ संगठनों के सामूहिक अभियान 'नेशनल इलेक्शन वाच' की विज्ञप्ति के मुताबिक इस दो दिवसीय सम्मेलन में भारत के तीन चुनाव आयुक्तों ने आने की स्वीकृति दी है। सम्मेलन में कई मांगें उठाई जाएंगी जिनमें इलेक्ट्रानिंग वोटिंग मशीन में 'इनमें से कोई नहीं' का विकल्प देने, गंभीर आरोपों वाले उम्मीदवारों के खिलाफ प्रतिबंध लगाने, चुनावी धांधली करने वाले उम्मीदवारों को अयोग्य करार देना और गैरजमानती वारंट वाले लोगों के नाम वोटर लिस्ट से हटाने जैसे मुद्दे होंगे। मेजबानी एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म करेगा। इस अभियान के प्रयासों के अहम नतीजे देखने को मिलें हैं और चुनावों में आपराधिक रिकार्ड वाले उम्मीदवारों की संख्या 20 से घटकर 12 फीसदी हो गई है।

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्मस (एडीआर) ने दिल्ली चुनाव में उतरे प्रत्याशियों की जानकारी देने के लिए एक हेल्प लाइन नंबर, एसएमएस सेवा और इंटरनेट पर सुविधा उपलब्ध कराई है। एडीआर के संयोजक अनिल बेरवाल ने बताया कि टाल फ्री नंबर 1-800-111515 पर कॉल करके अपने प्रत्याशी से जुड़ी जानकारी ले सकते हैं। प्रत्याशियों से जुड़ी आर्थिक, आपराधिक और पार्टी की जानकारी के लिए वेबसाइट (<http://www.adrindia.org>) भी उपलब्ध है। एडीआर ने एसएमएस सेवा शुरू करने की भी योजना बनाई है।

डेमोक्रेटिक रिफॉर्म (एडीआर) की अगुवाई में तैयार दिल्ली इलेक्शन वाच रिपोर्ट तैयार की गई है। रिपोर्ट में 69 सीटों से चुनाव मैदान में उतरे 863 प्रत्याशियों में से 91 के खिलाफ आपराधिक मुकदमे दर्शाए गए हैं। विशेष बात यह है कि भाजपा के 19, कांग्रेस के 19 और बसपा के 15 उम्मीदवारों के खिलाफ अलग-अलग धाराओं के आरोप दाखिल हुए हैं। कुल उम्मीदवारों की बात करें तो 14 फीसदी प्रत्याशी आपराधिक प्रवृत्ति के हैं।

एडीआर के राष्ट्रीय संयोजक अनिल बेरवाल कहते हैं कि भाजपा के लालकृष्ण आडवाणी और कांग्रेस के राहुल महाजन ने चुनाव से पहले आह्वान किया था कि आपराधिक प्रवृत्ति के प्रत्याशी नहीं बनाए जाएंगे। प्रत्याशियों ने जो शपथपत्र दाखिल किए हैं, उससे साफ खुलासा हो रहा है कि भाजपा के टिकट पर अंबेडकर नगर से चुनाव मैदान में उतरे सुरेश चांद पर हत्या का मुकदमा है, जबकि दोनों ही पार्टी के 28 फीसदी उम्मीदवार किसी न किसी तरह से दगी हैं। सोलमपुर से बसपा प्रत्याशी हाजी अफजल और रोहताश नगर से सपा के उम्मीदवार जितेन्द्र पांचाल के खिलाफ हत्या का मुकदमा दर्ज है। वह कहते हैं कि मतदाता को वोट देने से पहले अपने प्रत्याशी की छवि जरूर जान लें। ताकि चाहे-अनचाहे दगी को विधायक न बना दें।

नई दिल्ली। आप जिसे वोट देने जा रहे हैं, उसकी छवि के बारे में पहले जरूर जानें। कहीं ऐसा न हो कि आप ऐसे प्रत्याशी को चुनकर विधानसभा भेज दें, जिसके खिलाफ आपराधिक मामले दर्ज हों। दिल्ली विधानसभा चुनाव में उतरे 14 फीसदी प्रत्याशियों पर आपराधिक आरोप लगा चुके हैं।

आरोप भी ऐसा-वैसा नहीं बल्कि पांच के खिलाफ हत्या के प्रयास, तीन के खिलाफ हत्या, तीन के खिलाफ अपहरण, चार के खिलाफ वसूली और डकैती, बीस के खिलाफ धोखाधड़ी का आरोप है। यह सब कुछ प्रत्याशियों ने अपने शपथपत्र में भरा है। दिल्ली इलेक्शन वाच ग्रुप ने शपथ पत्रों को खंगालकर यह तथ्य मतदाताओं के सामने रखे हैं। एसोसिएशन फॉर

121 Congress crorepatis won; for BJP, 110 bagged seats

New Delhi: From the the recent assembly elections results, one can deduce that the more money you have, greater the chances of your winning a seat. A party-wise analysis shows the Congress fielded 121 crorepati winners and the BJP 110 in these polls. The candidates' declarations can be taken with a pinch of salt. In Rajasthan, for instance, an MLA with less than Rs 1 lakh assets owns a high-end car. "The study is based on their declarations and they may be lower than the actual assets," says Bairwal, whose study also concludes that the number of MLAs with criminal records has gone up since the 2003 polls. In Delhi, for instance, compared to 2003, the number of MLAs with criminal records has gone up from 24 to 27. That means now, 40% of newly elected MLAs in the 69-seat Delhi assembly have criminal records.

As per the affidavits, a total 549 candidates with criminal records contested in these elections. Of them, 124 won. That's about 23%. While MP has a maximum of 54 such MLAs, Rajasthan is second with 30, Chhattisgarh 11 and Mizoram 3. That deep pockets and crime go hand-in-hand is shown by Rajasthan, where the nine MLAs with serious criminal charges against them are all crorepatis.

Cong and BJP have 19 with criminal cases

New Delhi, Nov. 21: Nineteen candidates each fielded by the BJP and Congress for the upcoming Delhi Assembly polls have criminal cases pending against them, including serious offences like murder, attempt to murder and kidnapping.

Over 90 candidates out of the total 875 contesting the elections have criminal cases filed against them, with three candidates, including one from the BJP, facing murder charges.

The facts were brought to light by the Delhi Election Watch, an independent body comprising five organisations, including the Association for Democratic Reforms, Satark Nagrik Sangathan, NCPRI, Transparency International.

पांच राज्यों में हुए विधान सभा चुनावों के नतीजों से एक बार फिर साबित हो गया कि धन और बाहुबल चुनावी प्रक्रिया को काफी हद तक प्रभावित करते हैं।

इस बार चुनावी मैदान फतह करने वाले 40 प्रतिशत विधायक करोड़पति हैं जबकि कम से कम 20 प्रतिशत आपराधिक पृष्ठभूमि के हैं। न्यू इलेक्शन वाच कम्पेन के तहत एसीएसएन फार डेमोक्रेटिक रिफॉर्मस (एडीआर) द्वारा किए गए अध्ययन में यह बात सामने आई है। दिल्ली, राजस्थान, मध्य प्रदेश, छत्तीसगढ़ एवं मिजोरम में कुल 628 सीटों के लिए हुए चुनाव में 125 सीटें बाहुबलियों को प्राप्त हुई हैं जबकि 248 सीटें करोड़पतियों के कब्जे में आई हैं। मध्य प्रदेश के 54, राजस्थान के 30 और छत्तीसगढ़ के 11 बाहुबली विधायकों ने चुनावी जंग पर कब्जा किया है। दिलचस्प बात है कि मिजोरम में चुनाव मैदान में उतरे आपराधिक पृष्ठभूमि के तीनों उम्मीदवारों ने जीत हासिल की है। दिल्ली में कांग्रेस के आपराधिक पृष्ठभूमि के 59 और भारतीय जनता पार्टी के 49 विधायकों ने चुनाव जीता है। इस बार कुछ नए विधायक चुन कर आए हैं जिन पर हत्या, हत्या का प्रयास, जबरन उगाही, धोंधली, महिलाओं पर हमला आदि जैसे गंभीर आरोप हैं। इनमें से 13 मध्य प्रदेश के, 09 राजस्थान के, छह दिल्ली के, चार छत्तीसगढ़ के और तीन मिजोरम के हैं। इस बार के विधान सभा चुनावों में 40 प्रतिशत सीटों पर फतह करने वाले 82 मध्य प्रदेश के, 85 राजस्थान के, 46 दिल्ली के, 23 छत्तीसगढ़ के एवं 12 मिजोरम के करोड़पति हैं।

पांच राज्यों में हाल में हुए विधानसभा चुनावों में निर्वाचित हर पांचवां विधायक अपराधिक पृष्ठभूमि वाला है। एक गैर सरकारी संगठन ने अपनी रिपोर्ट में दावा किया है कि मध्य प्रदेश, राजस्थान, दिल्ली, छत्तीसगढ़ और मिजोरम में कुल नवनिर्वाचित 549 जनप्रतिनिधियों में से 124 का अपराधिक रिकार्ड है। रिपोर्ट के मुताबिक, अपराधिक रिकार्ड वाले कांग्रेसी विधायकों की संख्या 59 है जबकि ऐसे भाजपाई विधायकों की संख्या 49 है।

छत्तीसगढ़ में 30 सीटों के लिए कुल 1066 उम्मीदवार खड़े हुए। उनमें से करीब 76 की पृष्ठभूमि अपराधिक थी। यहां भाजपा के छह और कांग्रेस के पांच दागी उम्मीदवार जीत कर सत्ता के गलियारों में पहुंचे। इस तरह यहां के 12 फीसदी विधायक दागी हैं। रिपोर्ट के अनुसार, पांच राज्यों में सबसे स्वच्छ छवि मिजोरम की है। नवनिर्वाचित विधायकों में से कई पर सपीन आरोप हैं। राजस्थान में नौ विधायक हत्या, हत्या के प्रयास, अपहरण और बलात्कार के प्रयास जैसे आरोपों का सामना कर रहे हैं।

Delhi 2008 Assembly Elections

Delhi Assembly Elections 2008 were held during the month of November, 2008. A total of 875 candidates contested in the Delhi Assembly Elections, out of which Delhi Election Watch (DEW) & Association for Democratic Reforms (ADR) have analyzed the self-disclosed data of 790 candidates. This report includes the analysis of criminal, financial, and other details of 790 candidates and 68 MLAs (out of 70 MLAs).

This report is based on the analysis of information provided by the contesting candidates in their self-declared affidavits that they submit to the Election Commission of India (ECI). This affidavit constitutes the mandatory component of a candidate's nomination-papers so as to present his/her candidature for an election.

Representation of political parties

In 2003 Delhi Assembly Elections, 62 political parties contested which rose to 68 in 2008 Delhi Assembly Elections. This reflects a rise of 10% in the number of political parties contested from Delhi 2003 Assembly Elections to Delhi 2008 Assembly Elections.

Executive summary of Candidates and MLAs

Summary of Candidates

Delhi Election Watch (DEW) has analyzed affidavits of 790 out of 875 candidates who contested in the Delhi 2008 Assembly Elections.

Criminal

- **Candidates with Criminal Cases:** Out of these 790 candidates analyzed for Delhi Assembly Elections, 111 candidates or 14 % declared criminal cases against them.
- **Party wise Candidates with Criminal Cases:** Amongst major parties, every party has given tickets to candidates who have declared criminal cases. INC has 20 out of 67 (30 %), BJP has 22 out of 63 (35 %), BSP had 15 out of 64 (23%), LJP had 8 out of 37 (22%), SP had 5 out of 31 (16%), and NCP had 4 out of 15 (27%) candidates with declared criminal cases.
- **Candidates with Serious Criminal Cases:** Out of these 111 candidates with declared criminal cases, 32 (29%) have declared serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. INC has 4, BJP has 4, BSP has 3, LJP has 3, SP has 2, and NCP has 1 such candidate.
- **Candidates with Heinous & Violent Crime Cases:** The top three candidates who have declared serious criminal cases of murder, Attempt to murder, kidnapping and theft against them are: (1) Hazi Afzaz of BSP from Seelam Pur constituency has declared 3 charges related to murder and 3 charges related to attempt to murder. (2) Amit Kumar of LJP from Nerela constituency has declared 2 charge related to murder and 1 charges related to attempt to murder. (3) Bharat Singh of IND contesting from Najafgarh constituency has declared 1 charge related to murder and 1 charge related to attempt to murder.
- **Red Alert Constituencies:** There are a total of 15 Red Alert Constituencies (i.e. where 3 or more contesting candidates have declared criminal cases)

Financial

- **Average Assets:** Average Asset per candidate (of 790 candidates) in 2008 Delhi Assembly Elections is **Rs. 1.78 Crores**. Among major parties, the average asset per candidate for INC is **Rs 3.22 Crores** (67 candidates), for **BJP is Rs 4.19 Crores** (63 candidates), for **BSP is Rs 7.92 Crores** (64 candidates), for **LJP is Rs 24.41 lakhs** (37 candidates), and for **SP is Rs 98.35 lakhs** (31 candidates).
- **Crorepatri Candidates:** A total of **180 candidates** out of 790 analyzed i.e. 23% are crorepatis.
- **Highest Asset Candidates:** The top three candidates who have declared the highest assets are Ved Parkash of BSP from Mehrauli constituency who has declared the highest assets worth Rs. 217.05 crores, followed by Kanwar Singh Tanwar of BSP from Chhatarpur constituency with Rs. 157.08 crores worth of assets and Mohd.Sher Nabi Chaman an IND candidate from Babarpur constituency with assets worth Rs. 60.44 crores.
- **Low Assets:** A total of 5 candidates (out of 790 analyzed) have declared that they have zero assets. Also, 69 candidates (out of 790 analyzed) have declared assets less than Rs. 50,000 (and more than Rs. 0)
- **INC and BJP candidates with lowest assets:** Suresh Chand of BJP from Ambedkar Nagar constituency who has declared the lowest assets worth Rs 3.18 lakhs while Shabnam of INC candidate from Kirari constituency has lowest declared assets worth Rs 52 thousand.
- **High Liabilities:** A total of 9 candidates out of 790 analyzed have declared liabilities of Rs. 50 lakhs or above.
- **High Liability Candidates:** The top three candidates with highest liabilities are Jaideep Dass Gupta a BSP candidate from Shakur Basti who has declared the highest liabilities worth Rs. 2.65 Crores followed by Manjinder Singh Sirsa of BJP from Jangpura constituency with liabilities of Rs. 2.38 Crores and Kanwar Singh Tanwar of BSP from Chhatarpur constituency with liabilities worth Rs 2.19 crores.
- **Candidates with no PAN:** 322 (41%) out of 790 candidates analyzed in the Delhi 2008 Assembly Elections, have not declared their PAN details. 14 Crorepatri Candidates have not declared their PAN details.
- **Undeclared PAN Party Wise:** 5 out of 67 candidates of INC have not declared their PAN, 3 out of 63 of BJP have not declared their PAN, 6 out of 64 of BSP have not declared their PAN, 15 out of 37 of LJP, and 12 out of 31 of SP have not declared PAN details.

Other Background Details (Education, Age, Gender)

- **Candidate' Education:** A total of 236 (30%) candidates (out of 790 analyzed) are graduate or have higher educational qualification in the Delhi 2008 Assembly Election, while 483 (61%) are non graduates.
- **Candidates' Age:** A total of 7 candidates out of the total analyzed are more than 70 years of age. A total of 82 candidates are aged 30 or less.
- **1 Candidate declared his age to be less than 25 years** (Mohd. Alam of IND from Kalkaji constituency)
- **Candidates' Gender:** Total number of women candidates who contested in the Delhi Assembly Elections 2008 was 81 compared to 794 men candidates, i.e. only 9% of the candidates were women.

Summary of MLAs

Delhi Election Watch (DEW) has analyzed affidavits of the 68 MLAs (out of the maximum 70) of Delhi 2008 Assembly Elections.

Criminal

- **MLAs with Criminal Cases:** Out of these 68 MLAs analyzed for Delhi Assembly Elections, 29 MLAs or 43% have declared criminal cases against them.
- **Party wise MLAs with Criminal Cases:** Out of 24 MLAs of **BJP- 11 (46%)** have declared criminal cases, out of 39 MLAs of **INC- 15 (38%)** have declared criminal cases. There is only 1 Independent MLA, 1 MLA from RJD and 1 MLA from LJP and all of them have declared criminal cases against themselves.
- **MLAs with serious criminal cases:** Out of the 29 MLAs who have declared criminal cases against themselves, 6 (21%) MLAs declared serious criminal cases like murder, attempt to murder, kidnapping, theft etc.
- **MLAs with Heinous and Violent crimes cases:** The top three MLAs from major parties who have declared serious criminal cases of murder, attempt to murder, kidnapping and theft against them are: (1) Bharat Singh of IND from Najafgarh constituency who has declared 1 charge related to murder and 1 charge related to attempt to murder. (2) Kulwant Rana of BJP from Rithala constituency has declared 1 charge related to Kidnapping. (3) Asif Mohd. Khan of RJD from Okhla constituency has declared 1 charge related to theft.

Financial

- **Average Assets:** Average Asset per MLA (of 68 analyzed MLAs) in 2008 Delhi Assembly Elections is **Rs 3.05 Crores**. Among major parties, the average asset per MLA for **INC is Rs 2.65 Crores** (39 MLAs), for **BJP is Rs 3.27 Crores** (24 MLAs), for **BSP is Rs 4.81 Crores** (2 MLAs), for **RJD is Rs 78.15 Lakhs** (1 MLA) and for **LJP is Rs 28.06 Lakhs** (1 MLA).
- **Crorepati MLAs:** A total of 47 out of 68 MLAs analyzed i.e. 69% are crorepatis.
- **Highest Asset MLAs:** Bharat Singh of IND from Najafgarh constituency has declared the highest assets worth **Rs 14.45 Crore**, followed by Parduymn Rajput of BJP from Dwarka who has declared assets worth **Rs 12.73 Crore** and Sumesh of INC from Matiala constituency with assets worth **Rs 11.43 Crore**.
- **Low Assets:** Only 6 MLAs out of 68 have declared assets of less than Rs 25 lakh.
- **MLAs with low assets:** Sunil Kumar of BJP from Trilokpuri constituency has declared the lowest assets of **Rs. 5.15 lakhs**. Amrish Singh Gautam of INC from Kondli constituency has declared assets of **Rs. 8.35 lakhs**. Nand Kishore of INC from Vikaspuri constituency has declared assets of **Rs. 15.80 lakhs**.
- **Liabilities:** A total of 11 (16%) MLAs out of 68 analyzed have declared liabilities of Rs. 10 lakhs or above.

- **High Liability MLAs:** The top three MLAs with highest liabilities are Prof Jagdish Mukhi a BJP candidate from Janakpuri with declared the highest liabilities worth **Rs. 42.25 lakhs** followed by Dr.S.C.L.Gupta of BJP from Sangam Vihar constituency with liabilities of **Rs. 39.17 lakhs** and Arvinder Singh an INC MLA from Deoli constituency with liabilities worth **Rs 19.95 lakhs**.
- **MLAs with no PAN:** 4 (6%) out of 68 MLAs have not declared their PAN details

Other Background Details (Education, Gender, Age)

- **MLAs Education:** 56% MLAs (38 of 68 analyzed) are graduates or have a higher qualification in the Delhi Legislative Assembly of 2008 while 42% of MLAs are non graduates.
- **MLAs Gender:** Out of 70 MLAs in Delhi Assembly Elections, only 3 (4%) MLAs are women.
- **MLAs Age:** A total of 2 MLAs out of the 68 analyzed, are more than 70 years of age. A total of 10 MLAs are aged 40 or less.

Analysis based on declared criminal cases- Candidates

Affidavits of 790 candidates have been analyzed by Delhi Election Watch (DEW) for 2008 Assembly elections. Out of the 790 candidates, 111 or 14% have declared declared criminal cases against them. Out of these 111 candidates with declared criminal cases, 32 have declared serious criminal cases like murder, attempt to murder, kidnapping, extortion, etc. declared against them.

Party-wise break up of candidates with declared criminal cases

A total of 111 candidates contesting elections from Delhi have declared criminal cases against them. All major parties, every party has given tickets to candidates who have declared criminal cases. INC has 20 out of 67 (30 %), BJP has 22 out of 63 (35%) , BSP had 15 out of 64 (23%), LJP had 8 out of 37 (22 %), SP had 5 out of 31 (16 %), and NCP had 4 out of 15 (27%) candidates with declared criminal cases. The party wise break up is given below:

Analysis based on declared criminal cases – MLAs

Delhi Election Watch (DEW) has analyzed affidavits of 68 elected MLAs. Out of the 68 MLAs analyzed for Delhi Assembly election, 29 MLAs or 43% have declared criminal cases against them.

Party- wise break up of MLAs with declared criminal cases

Out of 24 MLAs of BJP- 11 (46%) have declared criminal cases, out of 39 MLAs of INC- 15 (38%) have declared criminal cases. There is only 1 Independent MLA, 1 MLA from RJD and 1 MLA from LJP and all of them have declared criminal cases against themselves.



Background on Association for Democratic Reforms (ADR) And National Election Watch (NEW)

About ADR & NEW

Association for Democratic Reforms (ADR) was established in 1999 by group of professors from Indian Institute of Management (IIM) Ahmedabad. In 1999, a Public Interest Litigation (PIL) was filed by them with Delhi High Court asking the disclosure of criminal, financial and educational background of the candidates contesting elections. Based on this, the Supreme Court in 2002 and subsequently in 2003, made it mandatory for all candidates contesting elections to disclose Criminal, Financial and educational background prior to the polls by filing an affidavit with Election Commission.

The first election watch was conducted by ADR in 2002 for Gujrat Assembly Elections whereby detailed analysis of the backgrounds of candidates contesting elections was provided to the electorate in order to help the electorate make an informed choice during polls. Since then ADR has conducted Election Watches for almost all state and parliament elections in collaboration with the National Election Watch. It conducts multiple projects aimed at increasing transparency and accountability in the political and electoral system of the country.

Our Achievements

- ADR won the NASSCOM award for ICT led Innovation by Multi-stakeholder Partnerships. This award was for the Election Watch software of ADR and Webrosoft.
- ADR won two milestone judgments on disclosure of candidate's criminal and financial records from the Supreme Court in May 2002 and March 2003 respectively. Since then, 1200 NGOs from all over the country are supporting ADR and ADR in partnership with its partners has organized Citizen Election Watch for all major elections and disclosed candidate's background information to the media and the public.
- The Election Commission has completed a massive exercise based on the Gujarat Election Watch report to verify information filed by candidates in the nomination papers and affidavits, and has started proceedings against candidates with false declarations.
- A Bill on Electoral Expenses was passed in September 2003. The EC has asked candidates to file a statement of expenses in every three days during the campaign. This information is made available to citizens on request to Returning Officers, District Election Officers and the CEOs.
- Civil Society non-partisan Election Watches are springing up in different states. In the Lok Sabha 2004 Elections, 19 States and 5 Union Territories carried out Election Watches. In the Lok Sabha 2009 elections, Election Watches were held in all states and union territories in the country.
- Bihar Election Watch in October-November 2005 resulted in intense pressure on the Chief Minister designate due to the extensive media coverage of candidate's background. As a result, for the first time, Bihar has a Council of Ministers without any known criminal record.
- The Election Commission inaugurated Civil Society led National Conferences on Electoral Reforms in Ahmedabad, Banglore, Patna, Lucknow, Mumbai, Bhopal and Chennai. These Conferences were action oriented and resulted in successful Election Watch campaigns.
- The EC issued several very significant orders in the last two years relating to candidate disclosure, ensuring those affidavits are complete, taking action against false affidavits based on complaints, and disclosing electoral expenses.

- In April 2008, ADR obtained a landmark ruling from the Central Information Commission (CIC) saying that Income Tax Returns of Political Parties would now be available in the public domain along with the assessment orders.
- In the Karnataka Assembly Elections, 2008, there was a reduction in the number of candidates with serious offenses put up by parties. There were 93 such cases against candidates in the 2008 elections, down from 217 in the 2004 assembly elections.
- Overall, the percentage of candidates with declared criminal cases came down from 20% to 14% in the assembly elections held in the country in 2008 for the states of Rajasthan, Chhattisgarh, Delhi, NCT of Delhi and Mizoram.
- A large number of candidates with serious declared cases that contested Lok Sabha 2009 elections like Pappu Yadav, Atiq Ahmed, Mukhtar Ansari, Akhilesh Singh, etc. lost.
- The number of total serious IPC sections against MPs decrease from 296 in Lok Sabha 2004 to 274 in Lok Sabha 2009.
- On Jan 25, 2010 both the Congress Chief Ms Sonia Gandhi and leader of opposition in Lok Sabha Ms Sushma Swaraj of BJP made public statements calling for a consensus on barring candidates with criminal backgrounds from contesting elections.
- On Feb 3, 2010 Prime Minister Manmohan Singh asked his Cabinet colleagues to disclose details of their assets and liabilities and refrain from dealing with the government on immovable property.
- Because of an RTI application that ADR has been following up with the CIC for nearly the past 2 years, the contribution reports of major political parties have been made public. Added to this is the fact that the Election Commission has taken proactive steps towards bringing in some level of accountability in the functioning of the political parties by getting the ICAI to develop reporting formats for political parties
- In May, 2010, the Chief Minister of Uttar Pradesh, Ms. Mayawati had announced the expulsion of about 500 party leaders with criminal past.
- In January 2011, the Election Commission of India entrusted the Institute of Chartered Accountants of India (ICAI) with the task of developing accounting format for political parties.
- Details of the movable and immovable assets of 30 Bihar ministers, including that of CM Nitish Kumar, were uploaded on the government website in January, 2011. It is seen as a step aimed at ending corruption promised by the Chief Minister himself.
