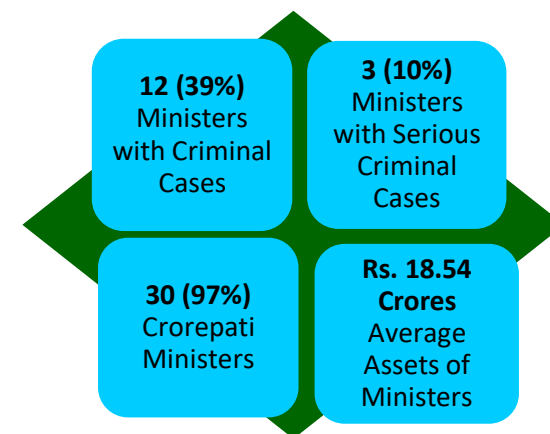

## Criminal Background

- **Ministers with Criminal Cases:** Out of the **31** ministers analysed, **12 (39%)** ministers have declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** **3(10%)** ministers have declared serious criminal cases against themselves.

## Financial Background

- **Crorepati Ministers:** Out of the **31** ministers analysed, **30 (97%)** are crorepatis.
- **Average Assets:** The average assets of **31** ministers analysed is **Rs 18.54 crores**.
- **Minister with Highest Assets:** The minister with the highest declared total assets is **Chetanya Kasyap** from **Ratlam City** constituency with assets worth **Rs. 296.08 crores**.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is **Gotam Tetwal** from **Sarangpur (SC)** constituency with assets worth **Rs. 89.64 Lakhs**.
- **Liabilities:** **25** ministers have declared liabilities out of which the minister with the highest liabilities is **Chetanya Kasyap** of **Ratlam City** constituency with **Rs. 20.17 crores** of liabilities.

### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

## Other Background details (Education, Gender, Age)

- **Ministers' Education:** **8 (26%)** ministers have declared their educational qualification to be between **8<sup>th</sup> pass and 12<sup>th</sup> pass**, while **23 (74%)** ministers have declared having an educational qualification of **graduate and above**.
- **Ministers' Age:** **5 (16%)** ministers have declared their age to be between **31 and 50 years** while **26 (84%)** ministers have declared their age to be between **51 and 70 years**.
- **Women Ministers:** Out of **31** ministers analysed, **5 (16%)** ministers are women.
