Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **79** winners out of **84** who had contested in the **21** multi member **wards** of the **Malegaon Municipal Corporation** Elections, held on **24th May, 2017**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Winners with Criminal Cases:** **18 (23%)** out of **79** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **12 (15%)** out of **79** analyzed winners have declared serious criminal cases against themselves like **attempt to murder, kidnapping, criminal intimidation, rape, assault or criminal force to woman with intent to outrage her modesty, etc.**
- **Party wise Winners with declared Criminal Cases:** **5 (22%)** out of 23 winners from **Indian National Congress (INC)**, **3 (15%)** out of 20 winners from **Nationalist Congress Party (NCP)**, **4 (44%)** out of 9 winners from **Bhartiya Janta Party (BJP)**, **3 (43%)** out of 7 winners from **All India Majlis E Ittehadul Muslimeen (AIMIM)** and **2 (33%)** out of 6 winners from **Janata Dal (Secular)** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with declared Serious Criminal Cases:** **4 (17%)** out of 23 winners from **Indian National Congress (INC)**, **1 (5%)** out of 20 winners from **Nationalist Congress Party (NCP)**, **2 (22%)** out of 9 winners from **Bhartiya Janta Party (BJP)**, **3 (43%)** out of 7 winners from **All India Majlis E Ittehadul Muslimeen**

Criteria for serious criminal cases

1. *Offence for which maximum punishment is of 5 years or more.*
2. *If an offence is non-bailable*
3. *If it is an electoral offence (for eg. IPC 171E or bribery)*
4. *Offence related to loss to exchequer*
5. *Offences that are assault, murder, kidnap, rape related*
6. *Offences that are mentioned in Representation of the People Act (Section 8)*
7. *Offences under Prevention of Corruption Act*
8. *Crimes against women.*

- **Party wise Crrepati Winners:** **6 (46 %)** out of 13 winners analysed from **Shivsena**, **3 (13%)** out of **23** winners analysed from **Indian National Congress (INC)**, **3 (15%)** out of **20** winners analysed from **Nationalist Congress Party (NCP)**, **2 (33%)** out of 6 winners analysed from **Janata Dal (Secular)** and **1 (14%)** out of **7** winners analysed from **All India Majlis E Ittehadul Muslimeen (AIMIM)**, are Crorepati.






