Summary and Highlights

Association for Democratic Reforms (ADR) and **Maharashtra Election Watch** have analysed the self-sworn affidavits of **146** winners out of **151** who had contested in the **38 wards** for the **Nagpur Municipal Corporation Elections**, held on **21st February, 2017**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Winners with Criminal Cases:** **28 (19%)** out of **146** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **17 (12%)** out of **146** analyzed winners have declared serious criminal cases against themselves like **attempt to murder, criminal intimidation, kidnapping, extortion, assault or criminal force to woman with intent to outrage her modesty, Cheating and forgery, etc.**
- **Party wise Winners with declared Criminal Cases:** **15 (14%)** out of 106 winners from **Bhartiya Janta Party (BJP)**, **10 (39%)** out of 26 winners from **Indian National Congress (INC)**, **1 (10%)** out of 10 winners from **Bahujan Samaj Party (BSP)** and **1 (50%)** out of 2 winners from **Shiv Sena** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with declared Serious Criminal Cases:** **10 (9%)** out of 106 winners from **Bhartiya Janta Party (BJP)**, **5 (19%)** out of 26 winners from **Indian National Congress (INC)**, **1 (10%)** out of 10 winners from **Bahujan Samaj Party (BSP)** and **1 (50%)** out of 2 winners from **Shiv Sena** have declared serious criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. *Offence for which maximum punishment is of 5 years or more.*
2. *If an offence is non-bailable*
3. *If it is an electoral offence (for eg. IPC 171E or bribery)*
4. *Offence related to loss to exchequer*
5. *Offences that are assault, murder, kidnap, rape related*
6. *Offences that are mentioned in Representation of the People Act (Section 8)*
7. *Offences under Prevention of Corruption Act*
8. *Crimes against women.*




