Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **114** winners out of **122** who had contested in the **31 wards** for the **Nasik Municipal Corporation** Elections, held on **21st February, 2017**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Winners with Criminal Cases:** **27 (24%)** out of **114** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **17 (15%)** out of **114** analyzed winners have declared serious criminal cases against themselves like **murder, attempt to murder, criminal intimidation, robbery, dacoity, assault or criminal force to woman with intent to outrage her modesty, cheating, etc.**
- **Party wise Winners with declared Criminal Cases:** **9 (15%)** out of 61 winners from **Bhartiya Janta Party (BJP)**, **12 (38%)** out of 32 winners from **Shiv Sena**, **3 (50%)** out of 6 winners from **Nationalist Congress Party (NCP)** and **2 (40%)** out of 5 winners from **Maharashtra Navnirman Sena (MNS)** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with declared Serious Criminal Cases:** **4 (7%)** out of 61 winners from **Bhartiya Janta Party (BJP)**, **8 (25%)** out of 32 winners from **Shiv Sena**, **2 (33%)** out of 6 winners from **Nationalist Congress Party (NCP)** and **2 (40%)** out of 5 winners from **Maharashtra Navnirman Sena (MNS)** have declared serious criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

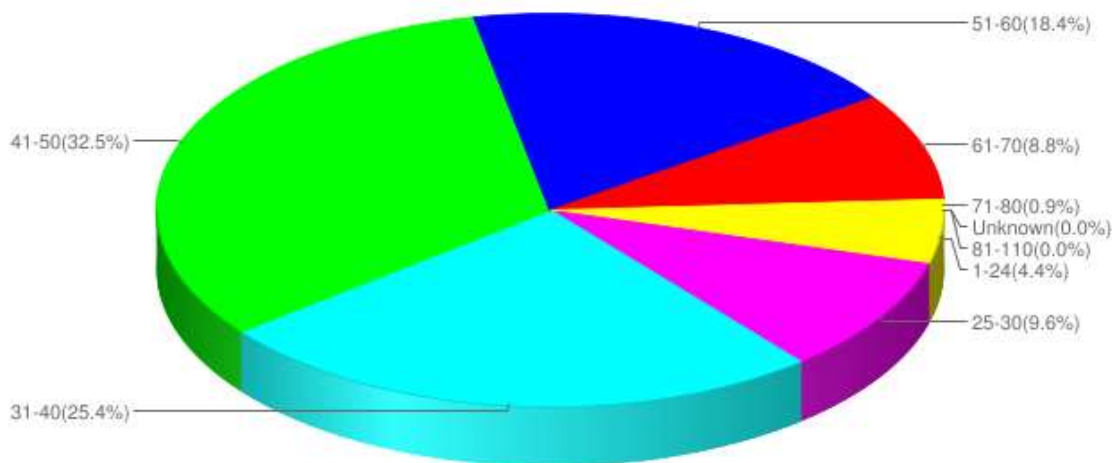

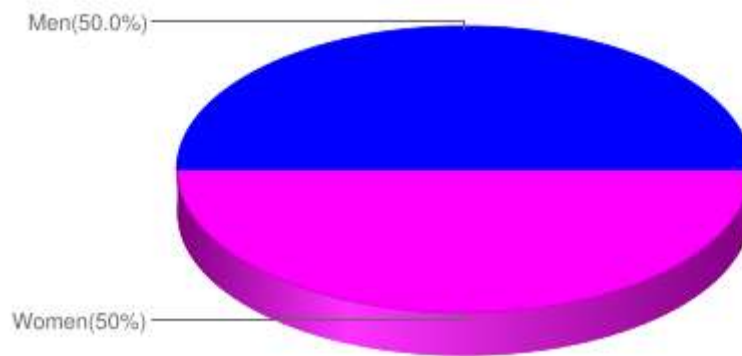
