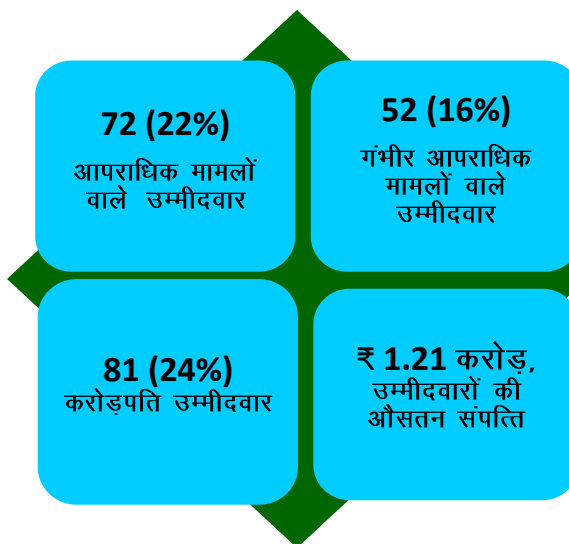

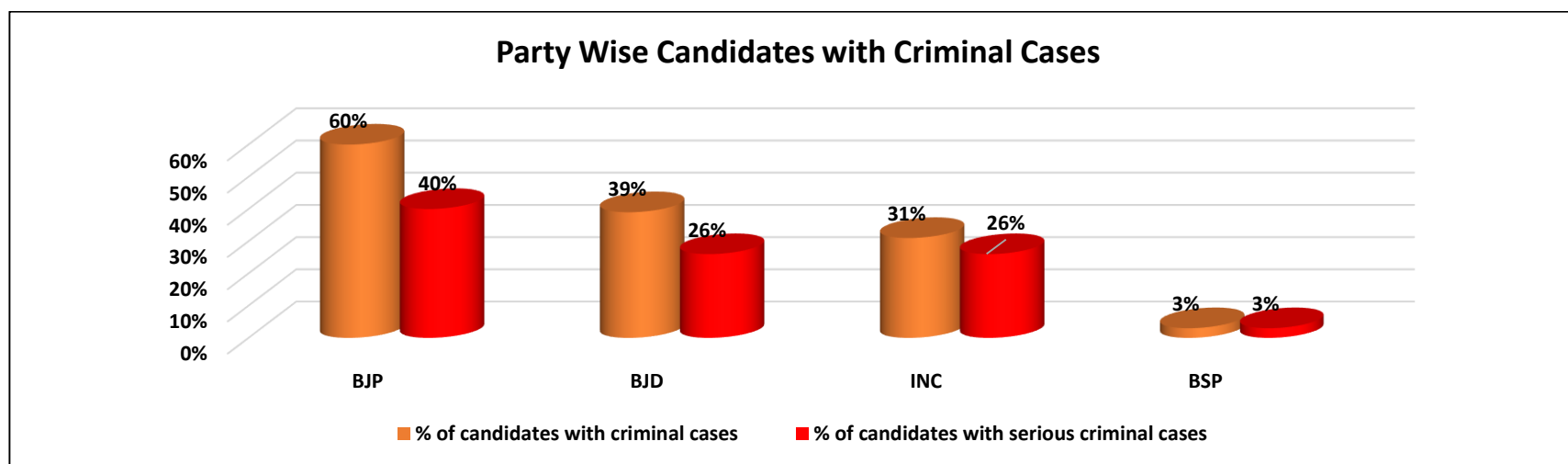

- ☞ उम्मीदवारों द्वारा घोषित गंभीर आपराधिक मामले:— 52 (16 प्रतिशत) उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।
- ☞ हत्या से सम्बन्धित मामले घोषित करने वाले उम्मीदवार: 3 उम्मीदवारों ने अपने ऊपर हत्या (आईपीसी-302) से सम्बन्धित मामले घोषित किये हैं।
- ☞ हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले उम्मीदवार: 11 उम्मीदवारों ने अपने ऊपर हत्या का प्रयास (आईपीसी-307) से सम्बन्धित मामले घोषित किये हैं।

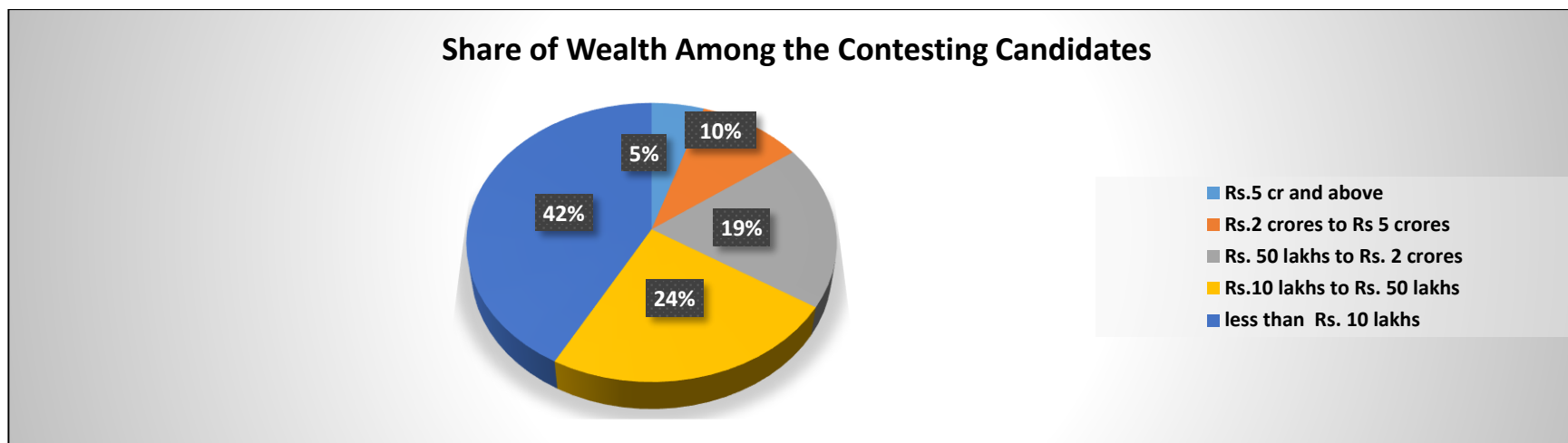

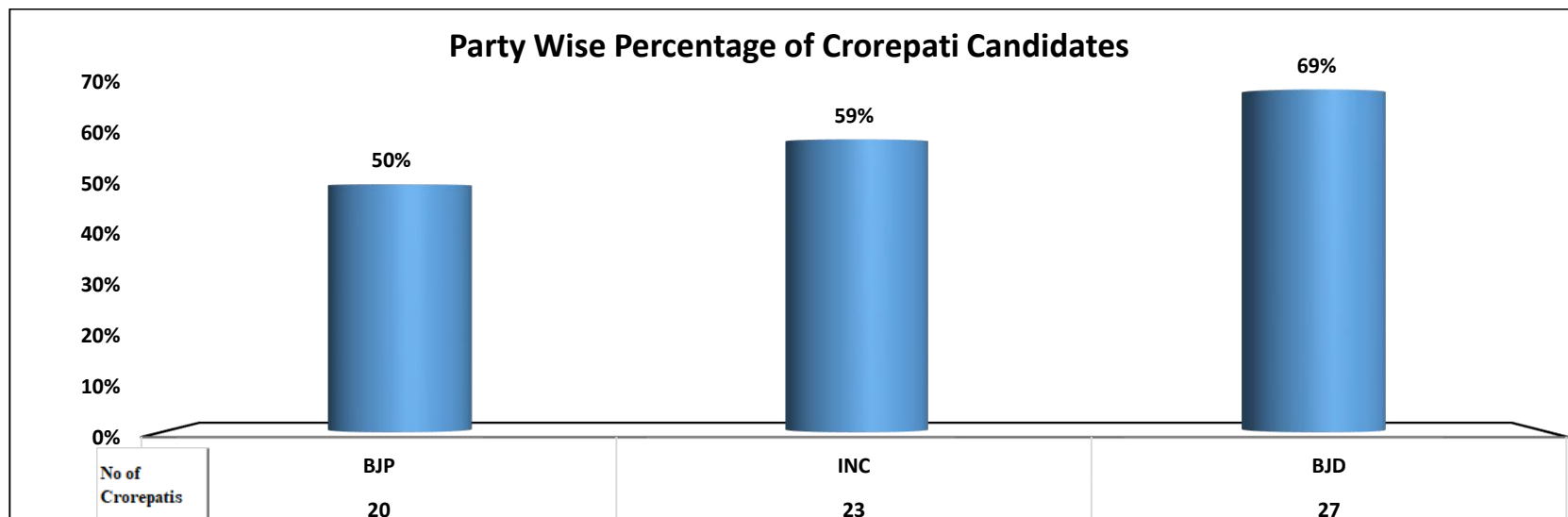

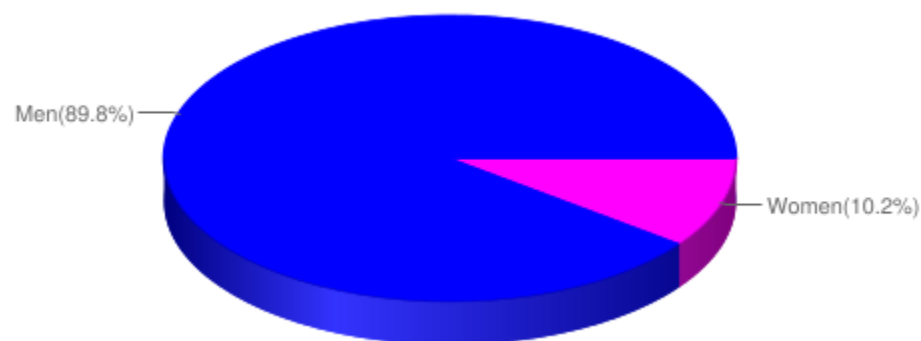
