Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **541** candidates out of **774** who are contesting for the **Pimpri Chinchwad Municipal Corporation** Elections, scheduled to be held on **21st February, 2017**. There are total **128 seats** spread across **32 wards** that will elect **4** members from each ward. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Candidates with Criminal Cases:** 63 (12%) out of 541 analyzed candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** 46 (9%) out of 541 analyzed candidates have declared serious criminal cases against themselves like **murder, attempt to murder, criminal intimidation, habitual dealing in slave, voluntarily causing grievous hurt by dangerous weapons or means, robbery, house-trespass, Cheating and dishonestly inducing delivery of property, etc.**
- **Party wise Candidates with declared Criminal Cases:**

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

14 (19%) out of 74 candidates analysed from **BJP**, 12 (17%) out of 70 candidate analysed from **NCP**, 8 (13%) out of 60 candidate analysed from **Shivsena**, 2 (5%) out of 39 candidate analysed from **INC** and 1 (4%) out of 23 candidates analysed from **MNS** have declared **criminal cases** against themselves in their affidavits.

- **Party wise Candidates with declared Serious Criminal Cases:** 9 (12%) out of 74 candidates analysed from **BJP**, 8 (11%) out of 70 candidate analysed from **NCP**, 6 (11%) out of 60 candidate analysed from **Shivsena**, 1 (3%) out of 39 candidate analysed from **INC** and 1 (4%) out of 23 candidates analysed from **MNS** have declared **criminal cases** against themselves in their affidavits.

- **Crorepati Candidates:** Out of the **541** analyzed candidates, **215 (40%)** are crorepatis.
- **Party wise Crorepati Candidates:** **50 (68%)** out of **74** candidates from **BJP**, **39 (56%)** out of **70** candidates from **NCP**, **26 (43%)** out of **60** candidate analysed from **Shivsena** and **10 (26%)** out of **39** candidate analysed from **INC** are Crorepatis.

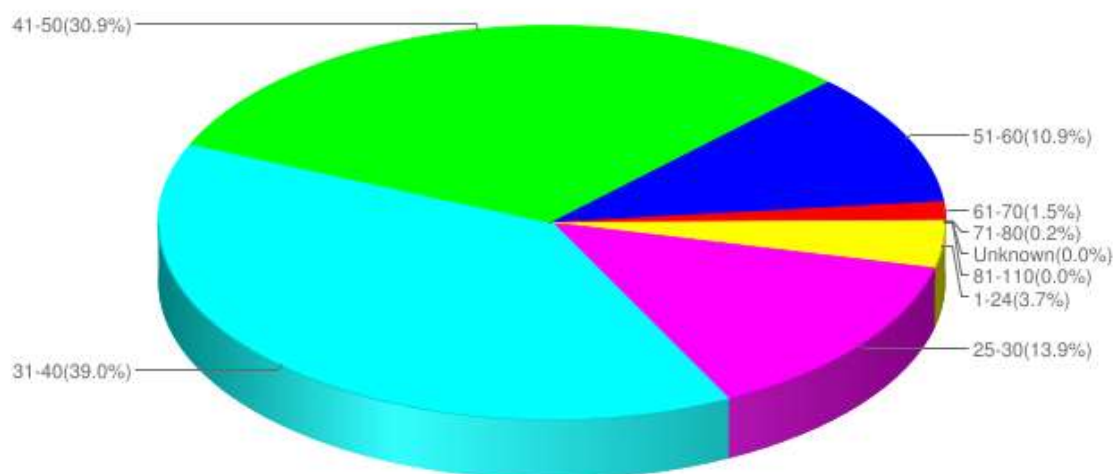

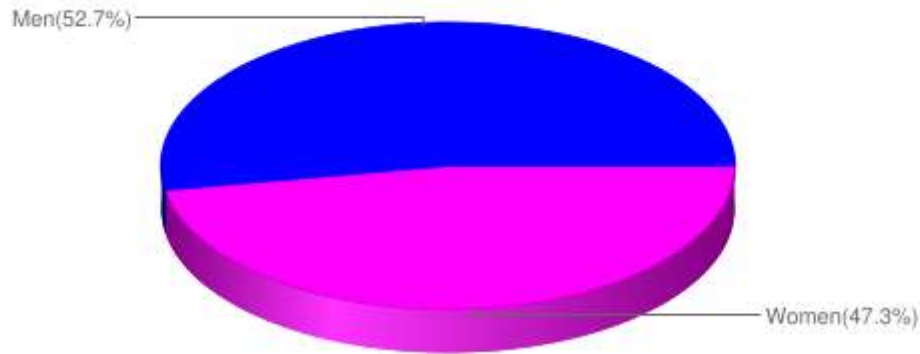
