## Executive Summary – Phase 1

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 80 candidates analysed, **21 candidates (26%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 21 candidates with criminal cases, **12 candidates have declared serious criminal cases** including cases related to **attempt to murder, crimes against women, theft etc.**
- **Candidates with multiple serious IPC counts:** 9 candidates have declared more than 1 serious IPC counts. **Pradeep Kumar Joshi** of **Rashtra Sewa Dal** from **Karakat** constituency has declared the highest serious IPC count of 17 followed by **Kaushal Yadav** of **JD(U)** from **Nawada** constituency with **12** serious IPC counts and **Raja Ram Singh** of **CPI(ML)L** from **Karakat** constituency with **3** serious IPC counts.
- **Party wise Candidates with Criminal Cases:** **3 (75%) out of 4** candidates fielded by **BJP**, **1 (17%) out of 6** candidates from **BSP**, **2 (33%) out of 6** candidates fielded by **AAP** and **3 (50%) out of 6** of **JD(U)** have declared criminal cases against themselves in their affidavits. **1 (4%) out of 24** independent candidates has declared criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** **3 (75%) out of 4** candidates fielded by **BJP**, **3 (50%) out of 6** candidates from **JD(U)**, and **2 (33%) out of 6** candidates from **AAP** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Attempt to Murder:** 4 candidates have declared cases related to attempt to murder. **Pradeep Kumar Joshi** of **Rashtra Sewa Dal** from **Karakat** constituency, **Kaushal Yadav** of **JD(U)** from **Nawada** constituency, **Raja Ram Singh** of **CPI(ML)L** from **Karakat** constituency and **Niranjan Kumar** of **CPI(ML)L** from **Gaya** constituency have declared cases related to attempt to murder.
- **Candidates with cases related to Crimes against Women:** **Karra Parasu Ramaiah** of **JD(U)** from **Sasaram** constituency has declared a case related to **Assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**. **Pradeep Kumar Joshi** of **Rashtra Sewa Dal** from **Karakat** constituency has declared a **charge related to causing miscarriage without woman's consent**.
- **Red Alert Constituencies\*:** 3 constituencies – **Karakat, Nawada and Aurangabad** - have at least 3 candidates from political parties with declared criminal cases.

**Criteria for serious criminal cases**

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Crorepatti Candidates:** Out of the 80 candidates contesting, **25 (31%)** are crorepatis.
- **Party-wise Crorepatti Candidates:** Both the candidates from INC, all 4 candidates from BJP and RJD have declared assets worth more than Rs. 1 crore. **2 (33%)** out of 6 candidates from AAP and **4 (67%)** out of 6 candidates from JD(U) are crorepatis.
- **Average Assets:** The average assets per candidate contesting in the 2014 Lok Sabha Elections from Bihar (Phase 1) is **Rs. 2.56 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets for 2 INC candidates is **Rs. 34.10 crores**, 4 BJP candidates have average assets of **Rs. 5.59 crores** while the average assets of 6 AAP candidates is **Rs. 70.21 lakhs**. The average assets of 6 JD(U) candidates is **Rs. 4.29 crores**, while the average assets of 6 BSP candidates is **Rs. 29.23 lakhs**.
- **High Asset Candidates:** **8** candidates have more than **Rs. 5 crores** worth of assets. Total Assets include self assets and others assets. The top three candidates with highest assets are given below:

- **Candidates who have not given value for Immovable Assets:** 14 candidates have not given value for atleast one immovable asset declared in their affidavits.
- **Candidates who have dues to Government Departments:** 8 candidates have dues to government departments.

- **Candidates with Liabilities:** A total of **36** candidates out of 80 have declared liabilities. **Pradeep Kumar Joshi** of RSD from Karakat constituency has the highest liabilities of **Rs. 1.19 crores** followed by **Sushil Kumar Singh** of BJP from Aurangabad constituency with **Rs. 73.21 lakhs** and **Chirag Kumar Paswan** of LJP from Jamui constituency with **Rs. 44.58 lakhs** worth of liabilities.
- **Candidates with High Income:** **Upendra Ravidas** of JMM from Jamui constituency has declared the highest income of **Rs. 80.46 lakhs**, while **Rajballabh Prasad** of RJD from Nawada constituency has declared an income of **Rs. 75.22 lakhs** and **Meira Kumar** of INC from Sasaram constituency has declared an income of **Rs. 58.87 lakhs**. \*Total income includes income of self, spouse and dependants
- **Candidates who have not declared Income Tax Details:** **39 (49%)** candidates out of 80 have not declared their income tax details. \*Some candidates may be exempted from filing Income Tax Returns.
- **Candidates with High Assets who have not declared Income Tax Details:** 6 candidate with assets worth more than Rs. 50 lakhs have not declared Income Tax details.
- **Undeclared PAN:** **24 (30%)** out of 80 candidates have not declared their PAN details.


