Analysis of Criminal, Financial and Other Background details of Candidates from Madhya Pradesh (Phase-1) for Lok Sabha 2014

Association for Democratic Reforms (ADR) and Madhya Pradesh Election Watch have analyzed the self-sworn affidavits of 110 candidates out of 118 contesting from Madhya Pradesh (Phase – 1) for Lok Sabha Election 2014 as given by the ECI.

The following candidates have not not been analysed due to non availability of affidavits or incomplete affidavits:

Executive Summary – Phase 1

Criminal Background

- **Candidates with Criminal Cases:** Out of the 110 candidates analysed, **17 candidates (15%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 110 candidates, **9 candidates** have declared serious criminal cases relating to attempt to murder, criminal intimidation etc.
- **Candidates with multiple serious IPC counts:** A total of 5 candidates have declared multiple serious IPC counts out of which **Phool Singh Dhurwey** of **CSM** from Mandla Constituency and **Ganesh Singh** of **BJP** from Satna constituency have declared **7 serious IPC charges** followed by and **Raju Baiga**, an Independent Candidate from Shahdol constituency, with **5 serious IPC charges**.
- **Party wise Candidates with Criminal Cases:** **4 (50%)** out of **8** candidates from **BSP**, **4 (44%)** out of **9** candidates fielded by **BJP**, **1 (33%)** out of **3** candidates from **SP**, **1 (14%)** out of **7** candidates from **AAP** and **1 (13%)** out of **8** candidates of **INC** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **2 (22%)** out of **9** candidates fielded by **BJP**, **1 (14%)** out of **7** candidates fielded by **AAP** and **1 (13%)** out of **8** candidates of **BSP** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Attempt to Murder:** **Sanat Kumar Tripathi**, of **Bhartiya Shakti Chetna Party** contesting from Sidhi constituency has declared one case related to attempt to murder
- **Candidates with cases related to Prevention of Corruption Act:** **Ganesh Singh**, a **BJP** candidate from Satna constituency has declared a case under Prevention of Corruption Act.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Red Alert Constituencies*: 2 constituencies in Madhya Pradesh (Phase – 1) have at least 3 candidates with declared criminal cases.

**Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections. This analysis excludes independent candidates with criminal cases.*

Financial Background

- **Crorepati Candidates:** Out of the 110 candidates analysed, **22 (20%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **8 (89%)** out of 9 candidates of **BJP** and **6 (75%)** out of 8 candidates of **INC**, **1 (33%)** out of 3 candidates of **SP**, **2 (29%)** out of 7 candidates of **AAP** and **1 (13%)** out of 8 candidates of **BSP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting from Madhya Pradesh – Phase 1 in Lok Sabha 2014 elections is **Rs. 3.42 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets of **8 INC** candidates is **Rs 36.39 crores**, **9 BJP** candidates have an average assets of **Rs 4.30 crores**, **7 AAP** candidates have average assets of **Rs 1.66 crores**, **3 SP** candidates have an average assets of **Rs 1.25 crores** and **8 BSP** candidates have average assets of **Rs. 1.21 crores**.
- **High Asset Candidates:** **10** candidates have declared more than **Rs. 5 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Candidates with zero assets:** Out of 110 candidates analysed, 3 candidates have declared having zero assets. **Brahmanand Pratap Singh**, an **Independent** Candidate from Sidhi constituency, **Baishakhoo Maravi**, a **Bhartiya Satya Sangharsh Party** candidate from Mandla constituency and **Ramesh**, an **Ambedkarite Party of India** candidate from Chhindwara constituency have declared zero assets
- **Low Asset Candidates:** Out of 110 candidates analysed, a total of **37** candidates have declared assets **less than Rs 3 lakhs** (including candidates with zero assets). The top three candidates with lowest assets are as follows:

- **Candidates who have not given value for Immovable Assets:** **21** candidates out of **110** analysed have not given value for atleast 1 immovable assets that they have declared in their affidavits.
- **Candidates with Liabilities:** A total of 40 candidates out of 110 analyzed have declared liabilities **out of which 4** candidates have declared liabilities **above Rs 1 crore**. **Kamal Nath** of **INC** from Chhindwara constituency has declared liabilities of **Rs. 5.11 crores** followed by **Deoraj Singh Patel** of **BSP** from Rewa constituency with liabilities of **Rs 1.79 crores**, **Mohd. Aftab Alam** of **BSP** from Jabalpur constituency with

liabilities of Rs 1.40 crores and Ajay Arjun Singh of INC from Satna constituency declaring total liabilities of Rs 1.38 crores

- **Candidates with High Income:** A total of 35 candidates have declared their income tax details out of which 8 candidates have declared a total income of more than Rs 15 lakhs. Vivekkrishna Tanka from Jabalpur constituency has declared the highest total income of Rs 14.24 crores followed by Kamal Nath from Chhindwara constituency with a total income of Rs 40.39 lakhs and Ajay Arjun Singh from Satna constituency with a total income of Rs. 38.75 lakhs all of whom are INC candidates. *Total income includes income of self, spouse and dependents
- **Candidates who have not declared Income Tax Details*:** 75 (68%) candidates out of 110 analyzed have not declared income tax details. * Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 8 candidates out of 110 analysed have declared assets of more than Rs 50 lakhs but have not declared Income Tax Details.
- **Undeclared PAN:** 43 (39%) out of 110 candidates analysed have not declared their PAN details.


