Analysis of Criminal, Financial and Other Background Details of Candidates from Maharashtra (Phase – 1) for Lok Sabha 2014

Association of Democratic Reforms (ADR) and Maharashtra Election Watch (MHEW) have analyzed the self-sworn affidavits of 200 out of the 201 candidates (as given by the ECI) who are contesting the 3rd Phase of the Lok Sabha 2014 elections from Maharashtra.

Executive Summary

Criminal Background

- **Candidates with Criminal Cases:** Out of 200 candidates analysed, **36 candidates (18%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 200 candidates analyzed, **19 candidates (10%)** have declared serious criminal cases including cases related to kidnapping, criminal intimidation, extortion etc.
- **Candidates with multiple serious IPC counts:** Ramdas Chandrabhanji Tadas of BJP from Wardha Constituency has declared the highest count of serious IPC charges i.e. **10**. He is followed by Ahir Hansraj Gangaram of BJP from Chandrapur Constituency with 6 IPC Counts and Bharatraje Uddhaorao Patil of MNS from Yavatmal- Washim Constituency, with 4 IPC Counts.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Candidates with Criminal Cases:** 5 (83%) out of 6 candidates fielded by BJP, 4 (57%) out of 7 candidates from INC, all 4 candidates of SHS, 1(10%) out of 10 candidates of BSP and AAP, 2 (33%) out of 6 candidates of SP, 1 (33%) out of 3 candidates of NCP, and 12 (13%) out of 95 Independent candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** 4 (67%) out of 6 candidates fielded by BJP, 3 (43%) out of 7 candidates of INC, 1 candidate each from SP, NCP, MNS, Bahujan Mukti Party, Akhil Bhartiya Manavta Paksh, Ambedkarwadi Republican Party and 6(6%) out of 95 Independent candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Kidnapping and Abduction:** Ahir Hansraj Gangaram of BJP from Chandrapur constituency has declared 1 charge related to Kidnapping, abducting or inducing woman to compel her marriage, etc (IPC Section-366)

Red Alert Constituencies*: 5 constituencies have at least 3 candidates from political parties with declared criminal cases.

**Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections. This analysis excludes independent candidates with criminal cases.*

Financial Background

- **Crorepati Candidates:** Out of the 200 candidates analysed, **46 (23%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All **7** candidates in **INC**, all **6** candidates in **BJP**, all **3** candidates in **NCP** and all **4** candidates in **SHS** have declared assets worth more than Rs. 1 crore. **5 (50%)** out of 10 candidates in **AAP** and **4 (40%)** out of 10 candidates in **BSP** are crorepatis.
- **Average Assets:** The average assets per candidate contesting in the 2014 Lok Sabha Elections from Maharashtra is **Rs.2.25 Crores**.
- **Party-wise Average Assets:** Among major parties, the average assets for **7 INC** candidates is **Rs 7.10 crores**, **6 BJP** candidates have an average assets of **Rs.4.60 crores**, **10 AAP** candidates have average assets of **Rs. 3.22 crores**, **4 SHS** candidates have average assets of **Rs. 4.40 crores** while **3 NCP** candidates have average assets of **Rs. 68.40 crores**.
- **High Asset Candidates:** **8** candidates have more than Rs. **5 crores worth of assets**. Total Assets includes Self Assets and Others Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of the 200 contesting candidates analyzed, a total of **29** candidates have declared assets **less than Rs.1 Lakh**. The three candidates with lowest assets are as follows:

- **Zero Asset Candidates:** 8 contesting candidates out of the 200 analyzed have declared that they have zero assets.
- **Candidates who have not given value for Immovable Assets:** 26 candidates have not given value for atleast one immovable asset declared in their affidavits.
- **Candidates who have dues to Government Departments:** 7 candidates have declared that they have dues to Government Departments.
- **Candidates with Liabilities:** A total of **11** candidates out of the 200 contesting candidates analyzed have declared liabilities above **Rs. 50 lakhs**. **Meghe Sagar Dattatraya** of **INC** from **Wardha** constituency has declared liabilities worth **Rs. 11.81 crores** followed by **Patel Praful Manoharbhai** of **NCP** from **Bhandara Gondiya** constituency with liabilities worth **Rs. 4 crores** and **Gaikwad Mohan Ramrao** of **BSP** from **Nagpur** constituency with liabilities worth **Rs. 3.39 crores**
- **Candidates with High Income:** **30** candidates have declared total Annual Income of **over Rs. 10 Lakhs**.

- **Candidates who have not declared Income Tax Details*: 96 (48%)** candidates out of the 200 contesting candidates analyzed have not declared income tax details. * Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details**: 14 candidates with assets worth more than Rs. 50 lakhs have not declared Income Tax Details.
- **Undeclared PAN**: 43(22%) out of the 200 contesting candidates analyzed have not declared their PAN details.

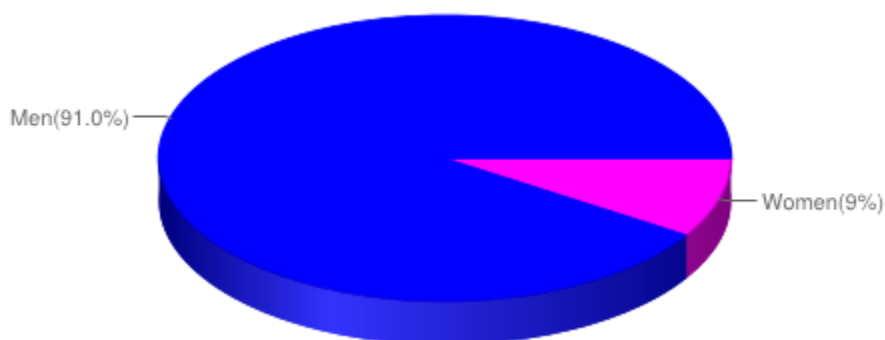
