Executive Summary – Phase 2

Criminal Background

- **Candidates with Criminal Cases:** Out of the 98 candidates analysed, **20 (20%) candidates** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 98 candidates, **12 candidates** have declared serious criminal cases relating to attempt to murder, intent to outraging a woman's modesty, criminal intimidation, promoting communal disharmony etc.
- **Party wise Candidates with Criminal Cases:** **6 (55%) out of 11 candidates** fielded by **BJP**, **2 (18%) out of 11 candidates** from **INC**, **1 (9%) out of 11 candidates** from **BJD**, **2 (18%) of 11 candidates** from **BSP** and **1 (10%) out of 10 candidates** of **AAP** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **2 (18%) of 11 candidates** fielded by **BJP**, **1 each (9%)** fielded by **INC** and **BSP** and **1 (10%) out of 10 candidates** of **AAP** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Attempt to Murder:** **Gayadhar Mallick** of **Samata Kranti Dal** from **Jajpur constituency** has declared a case related to attempt to murder (**IPC section 307**)
- **Candidates with cases related to Crimes against women:** **Jibesh Kishore Sundaray** of **AITC** from **Cuttack constituency** has declared a case related to **assault or criminal force to woman with an intent to outrage her modesty (IPC section 354)**
- **Candidates with cases related to Promoting communal disharmony:** **Ashok Sahu** of **BJP** from **Puri constituency** has declared a cases related to **promoting enmity between different groups on grounds of religion, race, place of birth, residence, language, etc., and doing acts prejudicial to maintenance of harmony (IPC Section-153A) and uttering, words, etc., with deliberate intent to wound the religious feelings of any person (IPC Section-298)**

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Red Alert Constituencies*: 2 out of 11 constituencies in Odisha (Phase – 2) have at least 3 candidates with declared criminal cases.

*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.

Financial Background

- **Crorepati Candidates:** Out of the 98 candidates analysed, **29 (30%)** are crorepatis.
- **Party-wise Crorepati Candidates:** Among major parties, **9 (82%)** out of 11 candidates of **INC**, **8 (73%)** out of 11 candidates of **BJD**, **4 (36%)** out of 11 candidates of **BJP**, **3 (30%)** out of 10 candidates of **AAP** and **1 (50%)** out of 2 candidates of **AITC** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in Odisha – Phase 2 in Lok Sabha 2014 elections is **Rs. 3.96 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset of **11 BJD** candidates is **Rs 23 crores**, **11 INC** candidates have an average assets of **Rs 2.53 crores**, **11 BJP** candidates have **Rs 1.06 crores**, **11 BSP** candidates have **Rs 26.66 lakhs** and **10 AAP** candidates have average asset of **Rs. 62.58 lakhs**.
- **High Asset Candidates:** **8** candidates have declared more than **Rs. 5 crores worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of 98 candidates analysed, a total of **6** candidates have declared assets **less than Rs 1 lakh**. The three candidates with lowest assets are as follows:

- **Candidates with Liabilities:** A total of 45 candidates out of 98 analyzed have declared liabilities **out of which 6** candidates have declared liabilities **above Rs 1 crore**. **Sunjoy Hans** of **Aama Odisha Party** from Bhubaneswar constituency has declared liabilities of **Rs. 14.36 crores** followed by **Rabindra Kumar Jena** of **BJD** from Balasore constituency with liabilities of **Rs 5.58 crores** and **Sangram Keshari Jena** of **INC** from Bhadrak constituency declaring total liabilities of **Rs 2.30 crores**
- **Candidates with High Income:** A total of 53 candidates have declared their income tax details **out of which 5** candidates have declared a total income of more than **Rs 1 crore**. **Rabindra Kumar Jena** of **BJD** from Balasore constituency has declared the highest total income of **Rs 6.64 crores** followed by **Pinaki Mishra** of **BJD** from Puri constituency with a total income of **Rs 3.92 crores** and **Sri Baijayant Panda** of **BJD** from Kendrapara constituency with a total income of **Rs. 3.57 crores**. **Total income includes income of self, spouse and candidates*
- **Candidates who have not declared Income Tax Details*:** **45 (46%)** candidates out of 98 analyzed have not declared income tax details. **Some candidates may be exempted from filing Income Tax Returns*

- **Candidates with High Assets who have not declared Income Tax Details:** 7 candidates out of 98 analysed have declared asset value of more than Rs 50 lakhs but have not declared Income Tax Details.
- **Undeclared PAN:** 18 (18%) out of 98 candidates analysed have not declared their PAN details.

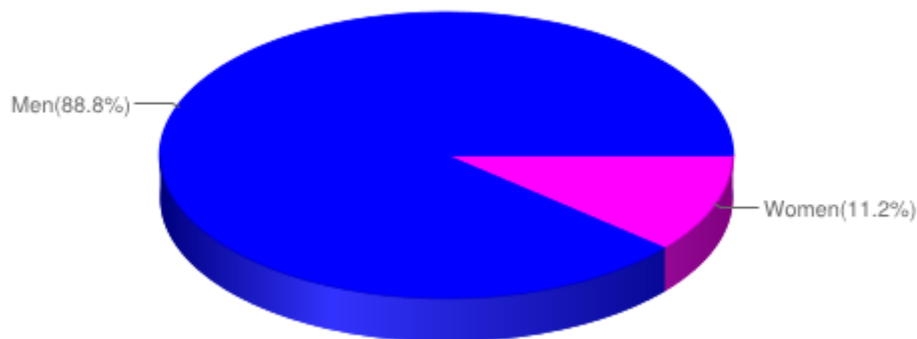
