Punjab 2007 Assembly Elections

Punjab Assembly Election, 2007 was held on 13th February, 2007. A total of 1055 candidates contested in the Punjab State Assembly Elections. Punjab Election Watch (PEW) & Association for Democratic Reforms (ADR) have analyzed the data of all 117 winners of the 2007 Punjab State Assembly Elections. This report includes the analysis of criminal, financial, educational and other details of these MLAs. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Representation of political parties

In Punjab 2002 Assembly Elections, 32 political parties contested which increased to 36 in Punjab 2007 Assembly Elections. This reflects an increase of 11% in the number of political parties contested in 2007 elections compared to 2002 elections.

Growth in number of candidates

Out of 1055 candidates contesting in 2007 Assembly Elections, there were 999 (95%) men and 56 (5%) women candidates. In 2002, out of 923 candidates who contested, 852 were men (92%) while 71 (8%) were women. Hence, the percentage of women candidates has decreased by 21% from 2002 Assembly Elections to 2007 Assembly Elections.

Executive summary of MLAs

- Affidavits of 117 MLAs were analyzed by Punjab Election Watch (PEW).
- Out of the 117 MLAs, 20 (17%) have pending criminal cases against them. Out of these 20 MLAs, 11 are from SAD, 7 from INC and 2 from BJP.
- Out of the 20 MLAs with pending criminal cases, there are pending serious criminal cases against 5 MLAs.
- Out of the 117 MLAs, 78 (i.e. 67%) are crorepatists.
- The average asset for an MLA from Punjab is Rs 3.42 crores.
- Out of 117 MLAs, 28 (24%) have not declared their PAN details.
- Out of 117 MLAs in Punjab, only 7 (i.e. 6%) are women.
- More than 50% of the MLAs (59 out of 117) are graduates or with higher educational qualification.

Analysis based on pending criminal cases-MLAs

Party-wise break up of MLAs with pending criminal cases

Out of the 117 MLAs, 20 MLAs (17%) declared pending criminal cases against them. SAD has 11 out of 49 (22 %), INC has 7 out of 44 (16 %) and BJP has 2 out of 19 (11 %) MLAs with pending criminal cases. Out of these 20 MLAs with pending criminal cases, 5 have pending serious criminal cases like attempt to murder, kidnapping, theft etc. against them. There were a total of 8 IPC charges of heinous nature on the MLAs. The party-wise break up of criminal records among MLAs is given below:

Overall Education report of MLAs

- A total of 2 (2% out of 117 analyzed) MLAs in Punjab 2007 Assembly Election are illiterate.
- A total of 17 (15%) MLAs out of 117 analyzed have educational qualification equivalent to 8th standard or below.
- A total of 59 (50%) MLAs (out of 117 analyzed) are graduate or with higher educational qualifications.

Women's representation in the Assembly

Out of 1055 candidates contested in Punjab 2007 Assembly Elections, the number of men candidates were 999 (95%) whereas the number of women candidates was only 56 (5%). Out of the 117 MLAs, the number of women MLAs is mere 7(6%).

- Only 1 MLA out of the 117 MLAs have declared their age to be less than 30 years.
- A total of 5 MLAs out of the total MLAs have declared their age to be more than 71 years of age.
