

महिलाओं पर बलात्कार/अन्य अपराध घोषित करने वाले सांसद/विधायक: राजनैतिक दलों द्वारा ऐसे उम्मीदवारों का चयन बरकरार

राजनैतिक दल ऐसे कई उम्मीदवारों को टिकट देते हैं, जिनके विरुद्ध महिलाओं के साथ बलात्कार के मामले दर्ज हैं। ऐसा करके व उन परिस्थितियों को बढ़ावा देते हैं जिनमें ऐसी घटनाएँ होती हैं जिनका संसद में वे पुरजोर विरोध करते हैं। आपराधिक पृष्ठभूमि वाले उम्मीदवारों को चुनाव लड़ने से वर्जित किया जाना चाहिए तथा राजनैतिक दलों को उम्मीदवार चुनने के मापदंड का खुलासा करना चाहिए। सांसदों तथा विधायकों के विरुद्ध आपराधिक मामलों को फास्ट ट्रैक कर के उन पर समयबद्ध तरीके से निर्णय लिया जाना चाहिए।

- ☛ चुनाव के समय भारत चुनाव आयोग को दिये गये अपने शपथपत्रों में 6 विधायकों ने अपने विरुद्ध बलात्कार के मामले घोषित किये हैं।
- ☛ बलात्कार जैसा मामले घोषित करने वाले 6 में से 3 सपा के विधायक हैं (उत्तरप्रदेश— श्रीभगवान शर्मा, अनूप संडा और मनोज कुमार पारस), 1 बसपा विधायक है (उत्तरप्रदेश—मौ0 अलीम खान), 1 भाजपा विधायक है (गुजरात—जेठाभाई जी अहिर) और 1 टीडीपी विधायक है (आन्ध्रप्रदेश—कंडीकुंता वैकटा प्रसाद)।
- ☛ 36 विधायकों ने अपने विरुद्ध महिलाओं पर अत्याचार से सम्बन्धित अपराध घोषित किये हैं जैसे—महिलाओं की लज्जा भंग करने के आशय से उस पर हमला या आपराधिक बल का प्रयोग, महिलाओं के साथ अवैध मार-पीट, और महिलाओं का अपमान इत्यादि
- ☛ महिलाओं पर अत्याचार से सम्बन्धित मामले घोषित करने वाले 36 में से कांग्रेस के 6 विधायक, भाजपा के 5 विधायक और सपा के 3 विधायक शामिल हैं।
- ☛ महिलाओं पर अत्याचार से सम्बन्धित मामले घोषित करने वाले विधायकों में उत्तरप्रदेश के सबसे ज्यादा 8 विधायक, उड़ीसा के 7 और पश्चिम बंगाल के भी 7 विधायक शामिल हैं।
- ☛ तमिलनाडू के निर्वाचन क्षेत्र सलेम से ए.डी.एम.के विधायक सेममलाई एस और तमिलनाडू के निर्वाचन क्षेत्र तमलूक से ए.आई.टी.सी के विधायक अधिकारी सुवेन्दु 2 ऐसे विधायक हैं जिन्होंने अपने विरुद्ध महिलाओं पर अत्याचार से सम्बन्धित मामलें घोषित किये हैं जैसे महिलाओं की लज्जा भंग करने के आशय से उस पर हमला या आपराधिक बल का प्रयोग इत्यादि।

उम्मीदवार

- गत पाँच वर्षों में राजनितिक दलों ने 27 ऐसे प्रत्याशीयों को चुनाव लड़ने के लिए टिकट दिए, जिन्होंने अपने विरुद्ध बालात्कार के मामले घोषित किये हैं।
- इनमे से 7 निर्दलीय प्रत्याशी हैं, 5 को सपा ने टिकट दिए हैं, 2 की भाजपा ने, 2 की बसपा ने तथा 1 प्रत्याशीया को कांग्रेस ने टिकट दिए हैं।
- इन 27 प्रत्याशीयों में से (जिनपर बालात्कार के मामले दर्ज हैं) 10 उत्तर प्रदेश से हैं तथा 5 बिहार से हैं।

पिछले पाँच सालों में राजनितिक दलों ने 260 अन्य ऐसे प्रत्याशीयों को चुनाव लड़ने के लिए टिकट दिए है। जिन्होंने अपने पर महिलाओं के विरुद्ध अपराध के मामले घोषित किए हैं। जैसे कि –

- इन 260 प्रत्याशीयों मे से (जिन्होंने अपने पर महिलाओं के विरुद्ध मामले दर्ज किए) 72 निर्दलिय, 24 भाजपा से, 26 कांग्रेस से, 16 सपा से तथा 18 को बसपा द्वारा टिकट दिए गए हैं।
- महाराष्ट्र मे से सर्वाधिक (41) प्रत्याशी हैं, इसके बाद उत्तर प्रदेश (37) तथा पश्चिम बंगाल से ऐसे 22 प्रत्याशी हैं।
- लोक सभा 2009 चुनावों में, राजनीतिक दलों ने 6 ऐसे प्रत्याशीयों को टिकट दिए हैं जिन्होंने बालात्कार के मामले घोषित किए हैं।
- इनमे से 1 RPP से, 1 RCP से, 1 BSP से, 1 JMM से, तथा 2 निर्दलीय उम्मीदवार हैं।
- इन 6 प्रत्याशियों मे से (जिनपर बालात्कार के आरोप हैं) 3 बिहार से, 1 दिल्ली से, 1 उत्तर प्रदेश और 1 आंध्र प्रदेश से है
- लोक सभा 2009 मे चुनाव लड़ रहे 34 अन्य उम्मीदवारों ने भी अपने पर महिलाओं के विरुद्ध अपराध के मामले घोषित किए हैं।
- महिलाओं के विरुद्ध अपराध के मामलों वाले इन 34 उम्मीदवारों मे से 12 निर्दलीय हैं, 4 बसपा से हैं, ए आई टी सी और सी पी आई (एम एल) (एल) से 2-2 उम्मीदवार हैं।
- महिलाओं के विरुद्ध अपराध के मामले वाले सर्वाधिक प्रत्याशी बिहार से 9 हैं, इसके बाद महाराष्ट्र से (6) तथा उत्तर प्रदेश से 5 प्रत्याशी हैं।

- ADR तथा NEW दृढ़ता से सिफारिश करता है कि राजनैतिक दलों को ऐसे प्रत्याशीयों को टिकट नहीं देना चाहिए जिनपर गंभीर आपराधिक मामले जैसे हत्या, हत्या का प्रयास तथा बालात्कार जैसे मामले दर्ज हैं।
