ORDER UNDER SECTION 7(2) OF THE RIGHT TO INFORMATION ACT, 2005

The petitioner Shri Anil Bairwal has requested the following information/details as per the RTI Act, 2005:

- i Have the below mentioned political parties received tax exemption for the financial years from AY 200-03 to FY 2012-13. (A list of 19 political parties appended).
- ii If yes, kindly provide the name of the party and the financial year(s) for which exemptions was given.

- iii Has any action been taken/notice issued to the above mentioned parties regarding filing of their income Tax returns? If so, kindly provide a copy of the notice and all such communication with these parties.
- 2.. It is hereby informed that political parties/electoral 'trusts do not fall under the jurisdiction of the undersigned. Trusts which are **public charitable/religious** in nature and AOPs which claim exemption under **sections.10,11 & 35** come under the purview of this office. Political parties which claim exemption u/s. 13A/13B of the Income Tax Act 1961 do not come within the ambit of this office. Therefore, the list of political parties mentioned in your petition does not fall under the jurisdiction of the undersigned.
- 3. I therefore, reject the petition filed by the applicant seeking information about Electoral Trusts as the information do not fall under the jurisdiction of this office. Hence, the RTI petition received in the office on 27.12.2012 filed by Shri Anil Bairwal, Association of Democratic Reforms, Table No.4, "Kiwanis Centre", 4th Floor B-35, Qutub Institutional Area, New Delhi-110016) hereby stands disposed on this day **07**th **January 2013.**
- 4. An appeal against this order, in terms of section 19(1) of the RTI Act, lies before the Joint Director of Income-tax (Exemptions), 121 Mahatma Gandhi Road Chennai 600 034. The appeal, if any, has to be filed within 30 days of receipt of this order.
