



Analysis of Criminal, Financial and other background details of newly elected MLAs of the Tripura Assembly Elections 2013

Summary and Highlights:

• Tripura Election Watch (TEW) has analysed affidavits of all 60 newly elected MLAs of Tripura 2013 Assembly Elections. Out of the 60 newly elected MLAs, 49 are from CPI(M), 10 are from INC and 1 is from CPI.

Financial:

- <u>Crorepati MLAs</u>: Out of these 60 MLAs, <u>8 (or 13%) are crorepatis</u>. In 2008, there were 5% crorepati MLAs (3 out of 60 MLAs in 2008).
- <u>Average Assets</u>: The Average Asset per MLA in Tripura Assembly Elections 2013 is Rs. 53.61 lakhs. In 2008 Tripura Assembly Elections for the 60 MLAs analysed the average asset per MLA was Rs. 29.98 Lakhs.
- Party-wise Average Assets: Among major parties, the average asset per MLA for CPI(M) is Rs. 27.59 lakhs and for INC is Rs. 1.83 crores. In 2008 the average asset per MLA for CPI(M) was Rs. 14.86 Lakhs and for INC it was Rs. 1.052 crores.
- <u>Highest Asset MLAs</u>: The top three MLAs with highest declared assets are (in decreasing order): <u>Dilip Sarkar</u> of INC from Badarghat (SC) constituency with <u>Rs. 4.58 crores</u> worth of assets and <u>Pranajit Singha Roy</u> of INC from Radhakishorpur constituency with assets worth <u>Rs. 4.03 crores</u> and <u>Biswabandhu Sen</u> of INC from Dharmanagar constituency with assets worth <u>Rs 2.25 crores</u>. From CPI (M) the MLA with highest assets is <u>Jitendra Choudhari</u> from Manu (ST) constituency with assets of Rs <u>1.55 crores</u>. (Please find later in the report the list of top 20 MLAs with highest declared assets who are the Tripura 2013 Assembly Elections)
- Low Asset MLAs: A total of 11 MLAs out of 60 analysed have declared assets less than Rs. 10 Lakh.
- Lowest Asset MLAs: <u>Diba Chandra Hrangkhawl</u> of INC from Karamchara constituency has declared the lowest assets of <u>Rs 6 thousand</u> followed by <u>Niranjoy Tripura</u> of CPI(M) from Chawmanu (ST) constituency has declared assets worth <u>Rs 88 thousand</u> and <u>Priyamani Debbarma</u> of CPI(M) from Karbook (ST) constituency with assets worth <u>Rs 1.10 lakhs</u>.
- Liabilities: A total of <u>9 MLAs</u> out of 60 analyzed have declared liabilities of <u>Rs. 10 lakhs or above</u>.
- <u>Highest Liability MLAs</u>: The top three MLAs with highest declared liabilities are(in decreasing order): <u>Jitendra Chaudhuri</u> a CPI(M) MLA from Manu (ST) constituency has declared the highest liabilities of <u>Rs. 28.24 lakhs</u> followed by <u>Rajendra Reang</u> of CPI(M) from Kanchanpur (ST) constituency with assets of <u>Rs 20.96 lakhs</u> and <u>Bijoy Lakshmi Singha</u> of CPI(M) from Kamalpur constituency with assets worth <u>Rs 15.03 lakhs</u>. From INC the MLA with highest liabilities is <u>Birajit</u> <u>Sinha</u> from Kailshahar constituency with liabilities worth <u>Rs 14.56 lakhs</u>.
- <u>Undeclared PAN</u>: <u>29 out of all 60 (48%)</u> MLAs in the Tripura 2013 Assembly Elections have not declared their PAN details. In 2008, 51 MLAs (85% of 60 analyzed) had not declared their PAN details.





- <u>Undeclared PAN Party-wise</u>: 27 out of 49 MLAs of CPI(M) have not declared their PAN. Similarly, for INC 2 out of 10 MLAs have not declared PAN details.
- MLAs who declared Income: <u>9 MLAs have declared an income in their ITR</u>. (Almost all other MLAs have claimed to be exempted from paying Income Tax under Section 10(26) of the Income Tax Act).
- <u>Highest Income MLAs</u>: Out of the 9 MLAs who have declared an income, the top three MLAs with the highest income are as follows: <u>Pranajit Singha Roy</u> of INC from Radhakishorpur constituency with total income worth <u>Rs</u> <u>30.38Lacs</u>. He is followed by <u>Birajit Sinha</u> of INC from Kailashahar constituency with total income of <u>Rs</u> <u>7.69 lakhs</u> and <u>Ratan lal Nath</u> of INC from Mohanpur constituency with total income worth <u>Rs</u> <u>7.66 lakhs</u>. From CPI(M) the MLA with declared highest income is <u>Bijita Nath</u> from Bagbassa constituencies with income of <u>Rs</u> <u>2.63 lakhs</u>.
- Chances of Winning based on Assets: Among the candidates with assets of Rs. 1 crore and above 8 have got elected, which means that if a candidate has Rs. 1 crore and more the chances of his winning the election is 50%. But chances of winning drops to only 6% if a candidate has assets less than Rs. 5 Lakhs, as only 7 candidates out of 108 with assets less than Rs. 5 lakhs have managed to win their elections.
- <u>Lakhpati candidates win over Crorepati candidates</u>: In 7 constituencies, Lakhpati candidates emerged as winners, defeating higher asset crorepati candidates in their respective constituencies.

<u>Criminal:</u>

- MLAs with declared criminal cases: Out of 60 MLAs, 6 <u>MLAs (or 10 %) have declared criminal</u> cases against themselves. All the 6 MLAs with declared criminal cases are from INC. In 2008 assembly elections, 5% of the MLAs (3 out of 60 MLAs) had declared criminal cases against themselves.
- <u>MLAs with Serious Criminal Cases</u>: Out of the total 6 MLAs who have declared criminal cases,<u>5</u> <u>have declared serious criminal cases</u> like murder, attempt to murder.
- <u>MLAs against whom charges have been framed</u>: Out of these 6 MLAs with self-declared criminal cases, <u>charges have been framed against 4 MLAs</u> in various cases. These are Ratan Lal Nath (INC), Gopal Chandra Roy (INC), Birajit Sinha(INC), and Biswabandhu Sen (INC).
- MLAs with Heinous & Violent Crime Cases: The top three MLAs from major parties who have declared maximum number of <u>serious criminal cases of murder, attempt to murder etc</u> against them are:(1)<u>Birajit Sinha</u> (of INC from Kailashahar constituency) has declared one charge related to <u>murder.(</u>2). <u>Ratan lal Nath(of INC from Mohanpur constituency)</u> has declared 1charge related to <u>attempt to murder</u> (3) <u>Gopal Chandra Roy</u> of INC from Banamalipur constituency has declared one charge related to attempt to <u>murder</u>.

Other Background details (Education, Gender, Age):

- <u>MLAs' Education</u>: A total of <u>28 (47%) MLAs (out of 60 analyzed) are graduates or have higher</u> <u>degrees</u> in the Tripura 2013 Assembly Elections. <u>20 MLAs (33%)are 10th Pass or below.</u>
- <u>MLAs' Age</u>: A total of 3 *MLAs, out of all the 60, are of 70 years and above.* 1 MLA is aged 40 or less Data in this Kit is presented in good faith, with an intention to inform voters.MLAs' affidavit with nomination papers is the source of this analysis. • <u>Women MLAs</u>: Out of 60 MLAs, <u>5 (8%) women are the Tripura 2013 Assembly Elections</u>. In 2008 there were 3 women MLAs (5% of the 60 analyzed).

Asset Comparison of Re-elected MLAs:

- MLAs elected Again: <u>43 MLAs have been re-elected</u> from the 2008 Tripura Assembly to the Tripura Assembly 2012.
- <u>Average Assets in 2008 Elections</u>: The average assets of these 43 re-elected MLAs fielded by various parties in 2008 was <u>Rs 25,15,729(25.15 Lakhs)</u>.
- Average Assets in 2013 Elections: The average assets of these 43 re-elected MLAs now in 2013 is <u>Rs</u> 48,93,386(48.93 Lakhs).
- <u>Average Asset growth in 5 years(2008-2013)</u>:The average asset growth for these 43 re-elected MLAs, between the Tripura Assembly Elections of 2008 and 2013, is <u>Rs 23,77,656 (23.77 Lakhs)</u>.
- Percentage growth in 5 years (2008-2013): Average percentage growth in assets for these 43 reelected MLAs is <u>95%</u>
- <u>Highest growth In Assets in 5 years (2008-2013)</u>: <u>Dilip Sarkar</u> (of INC from Badharghat) have increased by <u>Rs 2.03 crore</u>, from Rs 2.54 crore in 2008 to Rs 4.58 crore in 2013. <u>Sudip Roy Barman</u> (of INC from Agartala) have risen by <u>Rs 1.38 crore</u>, from Rs 69.39 Lakhs in 2008 to Rs 2.07 crore in 2013 (*In 2008, Sudip Roy Burman didn't provide the information related to the value of 1 Motor vehicle*). Assets of <u>Gopal</u> <u>Chandra Roy</u> (also a INC MLA from Banamalipur) have increased by <u>Rs 92.40 Lakhs</u>, from Rs 54.22 Lakhs in 2008 to Rs 1.46 crore in 2013.
- <u>Highest Percentage growth in 5 years (2008-2013)</u>: The highest percentage increase (8988%) in assets has been declared by <u>Subodh Das</u> of CPI (M) from Panisagar constituency. Subodh Das's assets increased from Rs. 3 Thousands* in 2008 to Rs 3.14* Lakhs in 2013. <u>Keshab Debbarma</u> of CPI (M) from Golaghati (SC) constituency falls at second position with <u>5945%</u> increase in assets; his assets have grown from Rs 61* Thousands in 2008 to Rs 37.35* Lakhs in 2013. <u>Aghore Debbarma</u> of CPI (M) from Khowai constituency falls at third position with <u>5397%</u> increase in assets; his assets have grown from Rs 66* Thousands in 2008 to Rs 36.51* Lakhs in 2013. (* this figure contains only that sum of money that has been explicitly provided in the affidavits, this figure doesn't include the value of assets for which value wasn't provided in the affidavits)
- Asset decrease in 5 years (2008-2013): 6 MLAs have reported decrease in assets in 2013 as compared to value of assets in 2008. Among them the highest decrease has been shown by <u>Padma Kumar</u> <u>Debbarma</u> (83% decline in assets, Rs 9.11 Lakhs in 2008 to Rs 1.58 lakhs in 2013) of CPI(M) from Ramchandraghat (ST) constituency, <u>Mano Ranjan Acharjee</u> (71% reduction in assets, from Rs 5.33 lakhs in 2008 election to Rs 1.54 lakhs in 2013) of CPI(M) from Amarpur, and <u>Basudev Majumder</u> (40% decline in assets, Rs 22.20 Lakhs in 2008 to Rs 13.31 lakhs in 2013) of CPI(M) from Belonia constituency. (* this figure contains only that sum of money that has been explicitly provided in the affidavits, this figure doesn't include the value of assets for which value wasn't provided in the affidavits)

Analysis based on declared criminal cases- MLAs

All the 60 affidavits of MLAs of Tripura 2013 assembly elections have been analyzed by Tripura Election Watch (TEW). Out of these 60 MLAs, 6 (10%) have declared that they have criminal cases against them. Out of these 6 MLAs with declared criminal cases, 5 have declared serious criminal cases like murder, attempt to murder etc. against them.

Party-wise break up of MLAs with declared criminal cases

A total of 6 MLAs in the Tripura elections 2013 have declared criminal cases against them. All of them are from INC . The party wise break up is given below:




