

Analysis of Criminal and other background details of Candidates contesting in the Tripura Assembly Elections 2013

Executive Summary

- Tripura Election Watch (TEW) has analyzed affidavits of 249 candidates out of 249 candidates who are contesting in Tripura 2013 Assembly Elections.
- Out of these 249 candidates, **19 candidates (or 8 %) have declared criminal cases against them.** In 2008 assembly elections, 3% of the contesting candidates (out of 301 candidates) had declared criminal cases against themselves.
- **Every major political party has given tickets to candidates who have declared criminal cases.** INC has 13 out of 48 (27 %), BJP has 1 out of 50 (2 %), CPI(M) has 1 out of 55 (2 %), IPFT has 1 out of 17 (6 %), and AmraBangalee has 1 out of 16 (6 %) candidates with declared criminal cases.
- **Candidates with Serious Criminal Cases:** Out of the total 19 candidates who have declared criminal cases, **10 have declared serious criminal cases** like murder, attempt to murder, kidnapping, robbery, extortion, etc. INC has 7 such candidates, IPFT has 1 and AmraBangalee has 1 such candidate.
- **Candidates against whom charges have been framed:** Out of these 19 candidates with self-declared criminal cases, **charges have been framed against 12 candidates** in various cases. These are Ratanlal Nath (INC), Gopal Chandra Roy (INC), Sujit Paul (IND), Birajit Sinha (INC), Biswabandhu Sen (INC), Rajendra Reang (IPFT), Rupesh Kumar Deb (AmraBangalee), Avijit Deb (INC), Advocate Bidyut Ghosh (BJP), Sajal Das (IND), Amitabha Datta (CPI(M)) and Baptu Chakraborty (INC).
- **Candidates with Heinous & Violent Crime Cases:** The top three candidates from major parties who have declared maximum number of **serious criminal cases of murder, kidnapping and theft** against them are: (1) Birajit Sinha (of INC from Kailashahar constituency) has declared one charge related to murder. (2) Premtosh Nath of INC from Sabroom constituency has declared one charge related to murder. (3) Ratanlal Nath (of INC contesting from Mohanpur constituency) has declared 1 charge related to attempt to murder.
- **1 Candidate has declared that he has cases registered against him under the "Prevention of Corruption Act"**, namely Chandi Charan Tripura (INC) from Manu (ST) constituency.
- **Candidates' Education:** A total of 94 (38%) candidates (out of 249 analyzed) are graduates or have higher degrees in the Tripura 2013 Assembly Elections.
- **Candidates' Age:** A total of 15 candidates, out of all the 249 that have been analyzed, are of more than 65 years of age.
- **Women Candidates:** Out of 249 contesting candidates, 15 (6%) women are contesting the Tripura 2013 Assembly Elections.

Analysis based on declared criminal cases- candidates

All the 249 affidavits who are contesting the Tripura 2013 assembly elections have been analyzed by Tripura Election Watch (TEW). Out of these 249 analyzed candidates, 19 (8%) have declared that they have criminal cases against them. Out of these 19 candidates with declared criminal cases, 10 have declared serious criminal cases like theft, kidnapping, attempt to murder etc. against them.

Party-wise break up of candidates with declared criminal cases

A total of 19 candidates contesting in the Tripura elections 2013 have declared criminal cases against them. INC has 13 out of 48 (27 %), CPI(M) has 1 out of 55 (2 %), IPFT had 1 out of 17 (2 %), BJP has 1 out of 50 (2 %), and 2 out of 20 (10 %) independent candidates have declared criminal cases. The party wise break up is given below:

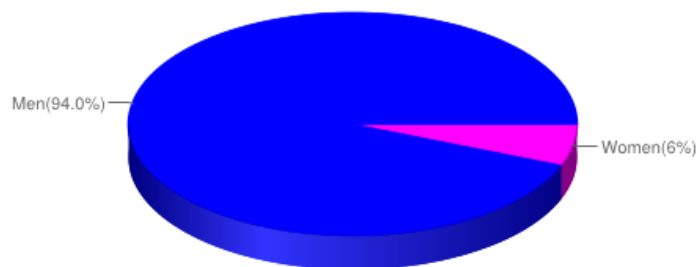
