



नेशलन इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफर्म्स ने लोक सभा 2019 और वर्तमान राज्य सभा से प्रधान मंत्री सहित 58 में से 56 मंत्रियों के शपथपत्रों का विश्लेषण किया। रामविलास पासवान और डॉ. सुब्रमण्यम जयशंकर का विश्लेषण नहीं किया गया है। क्योंकि वर्तमान में वो इन दोनों सदनों के सदस्य नहीं हैं।

- ☞ **हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले मंत्री**: महाराष्ट्र से BJP के राज्य सभा सदस्य वी. मुरलीधरन ने अपने ऊपर हत्या का प्रयास (आईपीसी-307) से सम्बन्धित मामला घोषित किया है।
- ☞ **सांप्रदायिक वैमनस्य से सम्बन्धित मामले घोषित करने वाले मंत्री**: 6 मंत्रियों ने अपने ऊपर धर्म, मूलवंश, जन्म स्थान, निवासस्थान, भाषा इत्यादि के आधारों पर विभिन्न समूहों के बीच शत्रुता का संप्रवर्तन और सौहार्द बने रहने पर प्रतिकूल प्रभाव डालने वाले कार्य करना (आईपीसी-153A) और विमर्शित और विद्वेशपूर्ण कार्य जो किसी वर्ग के धर्म या धार्मिक विश्वासों का अपमान करके उसकी धार्मिक भावनाओं को आहत करने के आशय से किये गये हों (आईपीसी-295A) से सम्बन्धित मामले घोषित किये हैं। नीचे की तालिका में उन मंत्रियों की सूची दी गई है।
