## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **119** out of **122 winners** who have contested the Kalyan Dombivali Municipal Corporation Elections of 2015. Remaining affidavits were not analysed as they were not uploaded at the time of making this report.

### Criminal Background

- **Winners with Criminal Cases:** Out of the 119 winners analysed, **30 (25%)** have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** Out of 119 winners analyzed, **26 (22%)** have declared serious criminal cases.
- **Party wise Winners with Criminal Cases:** **12 (24%)** out of 51 winners analysed from **Shiv Sena**, **11 (27%)** out of 41 winners analysed from **BJP**, **3 (33%)** out of 9 winners analysed from **MNS**, **1 (25%)** out of 4 winners analysed from **INC** and **1 (50%)** out of 2 winners analysed from **NCP** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with Serious Criminal Cases:** **12 (24%)** out of 51 winners analysed from **Shiv Sena**, **11 (27%)** out of 41 winners analysed from **BJP**, **1 (11%)** out of 9 winners analysed from **MNS** and **1 (50%)** out of 2 winners analysed from **NCP** have declared serious criminal cases against themselves in their affidavits.

<b><u>Criteria for serious criminal cases</u></b>
1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

## Financial Background

- **Crorepati Winners:** Out of the 119 winners analysed, **71 (60%)** are crorepatis.
- **Party-wise Crorepati Winners:** **29 (71%)** out of 41 winners analysed from **BJP**, **28 (55%)** out of 51 winners analysed from **Shiv Sena**, **4 (100%)** out of 4 winners analysed from **INC**, **4 (44%)** out of 9 winners analysed from **MNS** and **1 (50%)** out of 2 winners analysed from **NCP** are crorepatis.

- **Party-wise Average Assets:** Among major parties, the average asset per winner for 51 analysed **Shiv Sena** winners is approximate **Rs. 5.10 crore**, 41 analysed **BJP** winners have average assets of **Rs. 4.91 crore**, 9 analysed **MNS** winners have average assets of **Rs. 3.78 crore**, 4 analysed **INC** winners have average assets of **Rs. 4.99 crore**, 2 analysed **NCP** winners have average assets of **Rs. 22.86 crore**, 1 analysed **AIMIM** winner has average assets of **Rs. 16 lacs** and 1 analysed **BSP** winner has average assets worth Rs. 1 lac.






