## Summary and Highlights

**Association for Democratic Reforms (ADR)** and **Maharashtra Election Watch** have analyzed the self-sworn affidavits of all **95** winners who had contested in the **24** multiple member wards of the **Mira Bhayander Municipal Corporation (MBMC) Elections**, held on **20<sup>th</sup> August, 2017** in Maharashtra.

## Criminal Background

- **Winners with Criminal Cases: 27 (28%)** out of **95** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases: 17 (18%)** out of **95** analyzed winners have declared serious criminal cases against themselves like **culpable homicide not amounting to murder, extortion, criminal intimidation, forgery, cheating, etc.**
- **Party wise Winners with declared Criminal Cases: 21 (34%)** out of 61 winners from **Bhartiya Janata Party**, **4 (18%)** out of 22 winners from **Shivsena** and **1 (10%)** out of 10 winners from **Indian National Congress** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with declared Serious Criminal Cases: 14 (23%)** out of 61 winners from **Bhartiya Janata Party** and **2 (9%)** out of 22 winners from **Shivsena** have declared **serious** criminal cases against themselves in their affidavits.

### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act

- **Party wise Crorepati Winners:** **47 (77%)** out of 61 winners analyzed from **Bhartiya Janata Party (BJP)**, **18 (82%)** out of 22 winners analyzed from **Shivsena** and **6 (60%)** out of 10 winners analyzed from **Indian National Congress** are crorepatis.






