आपराधिक पृष्ठभूमि

☞ विधायकों द्वारा घोषित आपराधिक मामले:— 147 में से 52 (35 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। 2009 विधानसभा चुनाव में विधायकों द्वारा घोषित आपराधिक मामले— 134 में से 42 (31 प्रतिशत)।

☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:— 52 विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। 41 विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। जिनमें हत्या का प्रयास, बलात्कार, अपहरण, महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध इत्यादि शामिल हैं।

☞ विधायकों द्वारा घोषित आपराधिक मामले:—दलवार : बीजू जनता दल के 117 में से 32 (27 प्रतिशत), भाजपा के 10 में से 8 (80 प्रतिशत), कांग्रेस के 16 में से 9 (56 प्रतिशत), विधायकों ने अपने ऊपर आपराधिक मामलों घोषित किये हैं।

☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:—दलवार : बीजू जनता दल के 117 में से 23 (20 प्रतिशत), भाजपा के 10 में से 7 (70 प्रतिशत), कांग्रेस के 16 में से 8 (50 प्रतिशत), विधायकों ने अपने ऊपर गंभीर आपराधिक मामलों घोषित किये हैं।

☞ हत्या के प्रयास से सम्बन्धित मामले घोषित करने वाले विधायक : 8 विधायकों ने अपने ऊपर हत्या के प्रयास से सम्बन्धित मामले घोषित किये हैं।

गंभीर आपराधिक मामलों के लिए मापदंड

1. पांच साल या उससे अधिक सजा वाले अपराध
2. गैर जमानती अपराध
3. चुनाव से सम्बन्धित अपराध (धारा 171 अथवा रिश्वतखोरी)
4. सरकारी खज़ाने को नुकसान पहुंचाने से सम्बन्धित अपराध
5. हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध

- ☞ डकैती और चोरी से सम्बंधित मामले घोषित करने वाले विधायक : 3 विधायकों ने अपने ऊपर डकैती और चोरी से संबंधित मामले घोषित किये हैं।
- ☞ अपहरण से सम्बंधित मामले घोषित करने वाले विधायक : 4 विधायकों ने अपने ऊपर अपहरण से सम्बंधित मामले घोषित किये हैं।
- ☞ महिलाओं के ऊपर अत्याचार से सम्बंधित मामले घोषित करने वाले विधायक: 6 विधायकों ने अपने ऊपर महिलाओं पर अत्याचार से सम्बंधित मामले घोषित किये हैं।
सुबल साहू (कांग्रेस/निर्वाचन क्षेत्र— बिजेपुर) ने अपने ऊपर बलात्कार से सम्बंधित मामला घोषित किया है।
- ☞ गंभीर आपराधिक मामले वाले उम्मीदवार जो चुनाव हार गए : 218 गंभीर आपराधिक मामलों वाले उम्मीदवार ओडिशा 2014 विधानसभा चुनाव में चुनाव हार गए।

वित्तीय पृष्ठभूमि

- ☞ करोड़पति विधायक : नव निर्वाचित 147 में से 76 (52 प्रतिशत) विधायक करोड़पति हैं। 2009 ओडिशा विधानसभा चुनाव में 32 (24 प्रतिशत) विधायक करोड़पति थे।
- ☞ करोड़पति विधायक—दलवार : बीजूजनतादल के 117 में से 62 (53 प्रतिशत), भाजपा के 10 में से 4 (40 प्रतिशत), कांग्रेस के 16 में से 9 (56 प्रतिशत), विधायक करोड़पति हैं।
- ☞ औसतन संपत्ति : ओडिशा विधानसभा चुनाव 2014 में 147 विधायकों की औसतन संपत्ति 3.22 करोड़ है जबकि 2009 ओडिशा विधानसभा चुनाव में 134 विधायकों की औसतन संपत्ति 1.56 करोड़ थी।

☞ औसतन संपत्ति-दलवार : मुख्य दलों में बीजू जनता दल के 117 विधायकों की औसतन संपत्ति 2.03 करोड़, भाजपा के 10 विधायकों की औसतन संपत्ति 13.44 करोड़, कांग्रेस के 16 विधायकों की औसतन संपत्ति 1.92 करोड़ है।

- ☞ विधायकों की आयु : 147 में से 73 (50 प्रतिशत) विधायकों ने अपनी आयु 25 से 50 वर्ष के बीच घोषित की है और 63 (43 प्रतिशत) विधायकों ने अपनी आयु 51 से 70 वर्ष के बीच घोषित की है 11 विधायकों ने अपनी आयु 70 वर्ष से अधिक घोषित की है।
